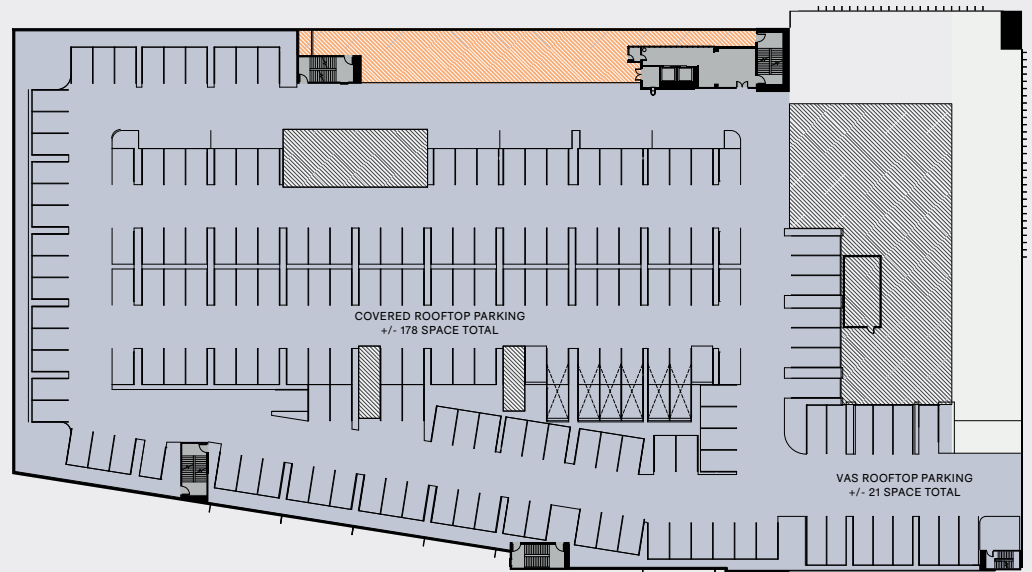


Floor Plan
