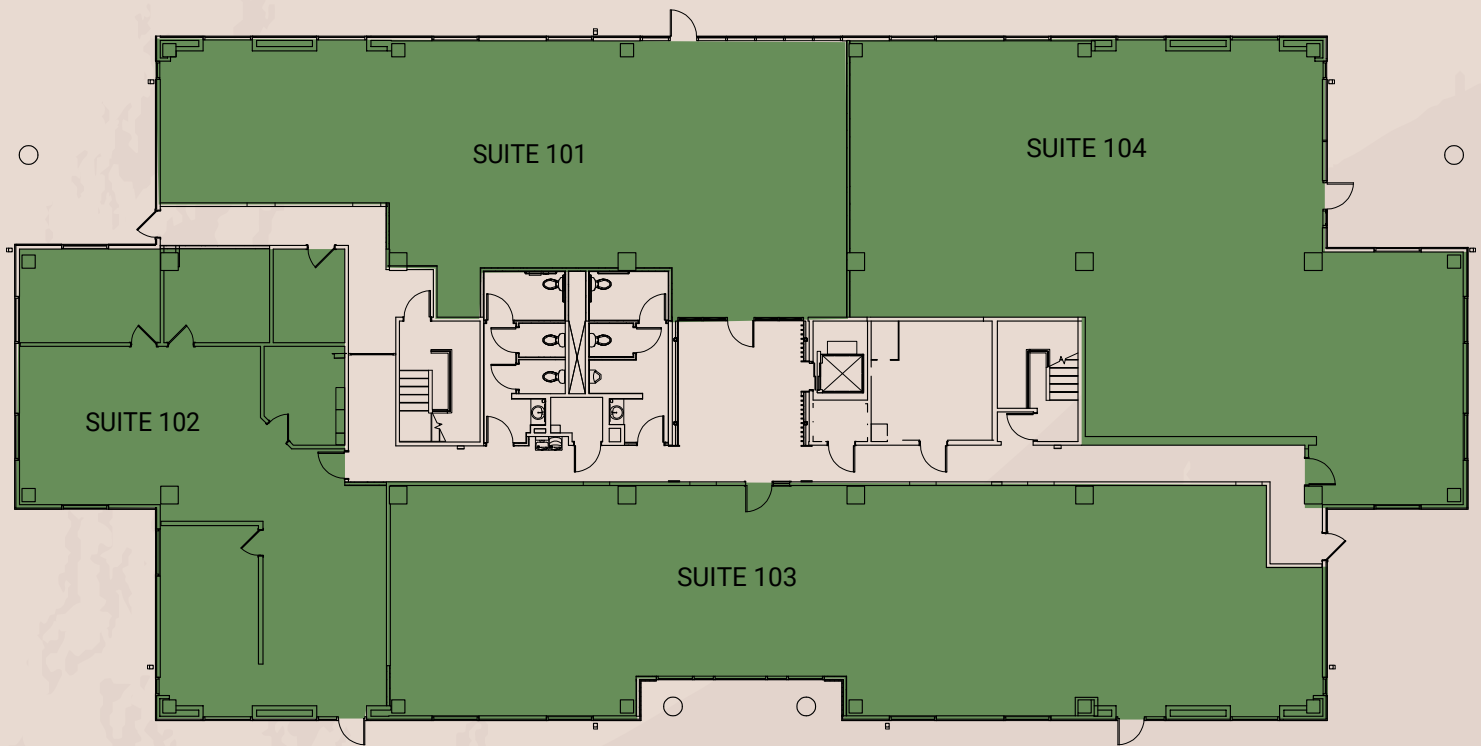

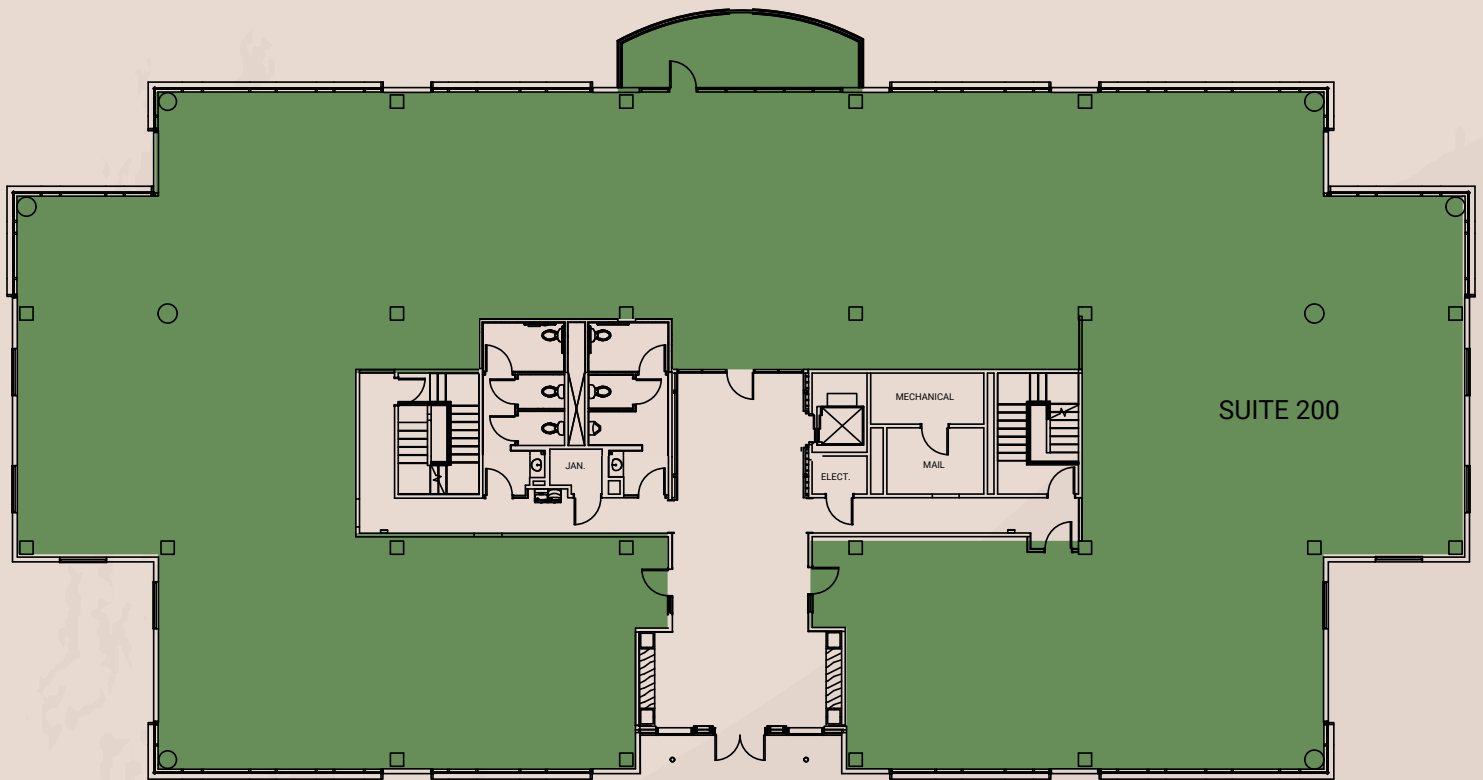

1st Floor plan



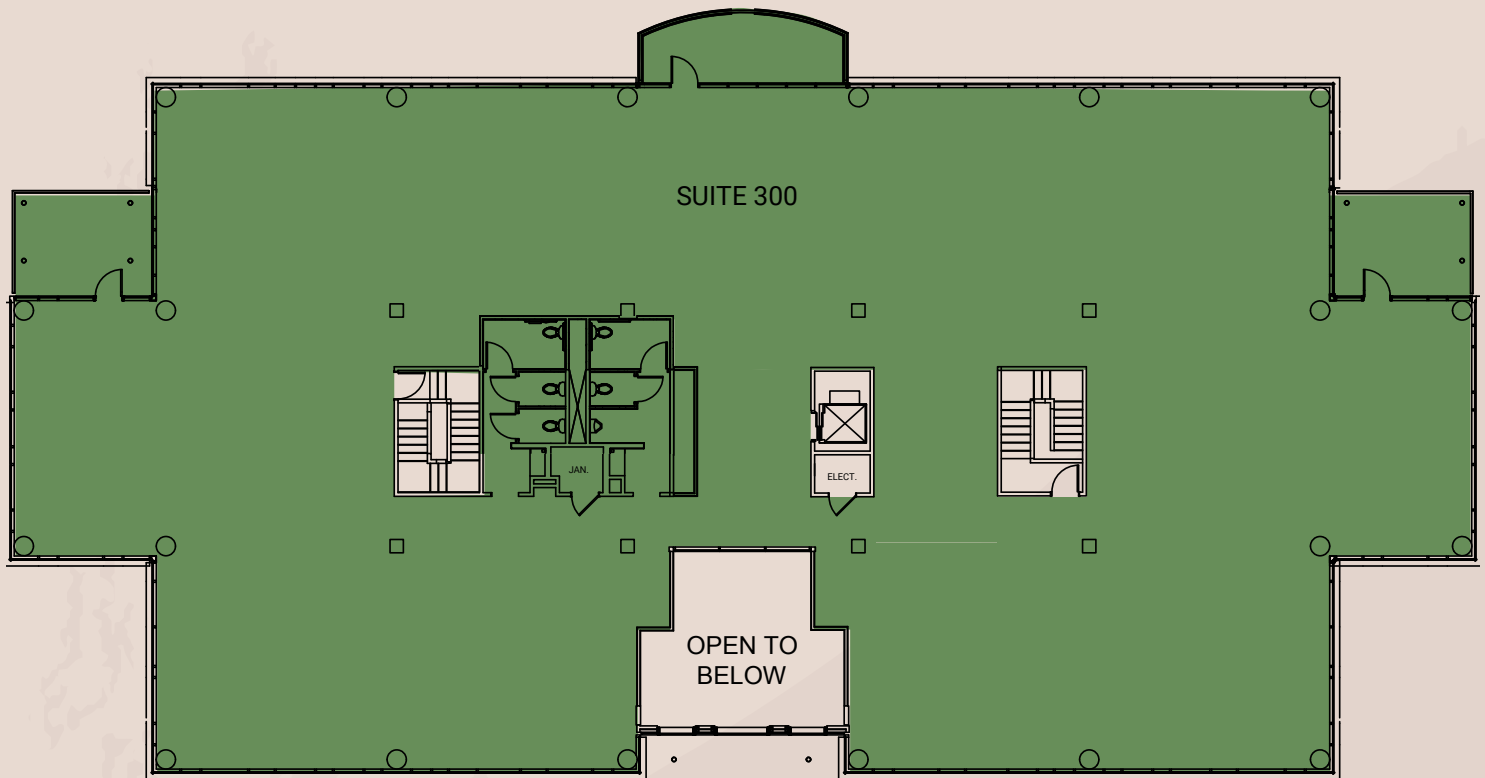
