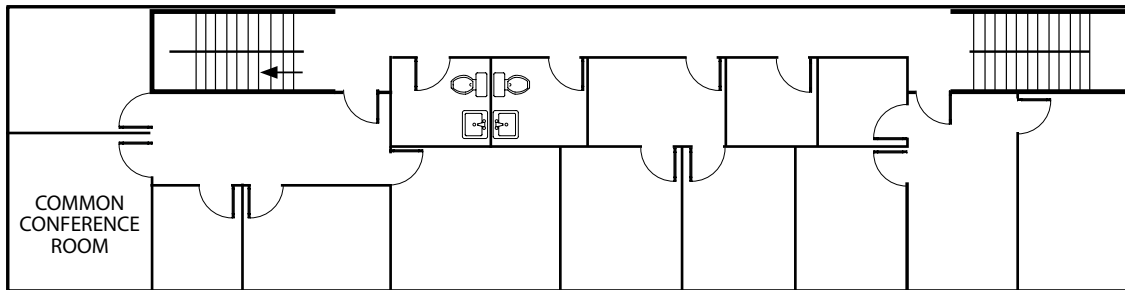

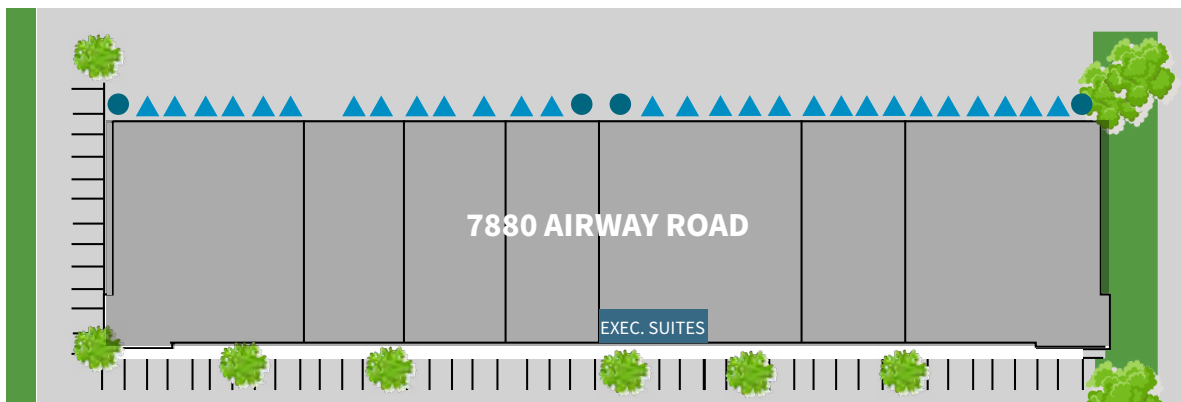
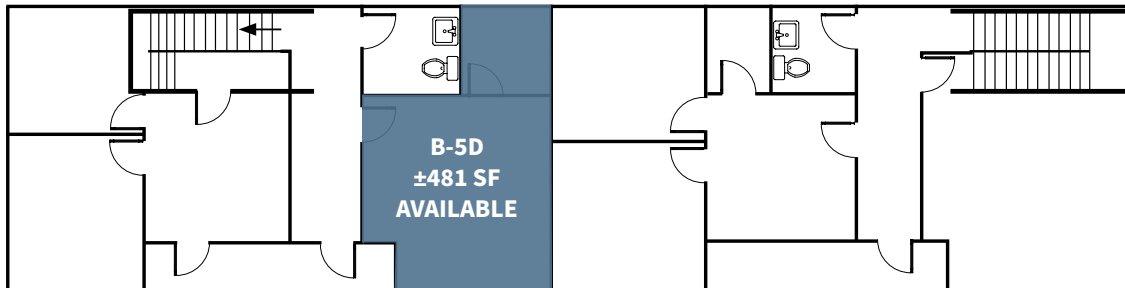


▲ DOCK HIGH DOOR (2)

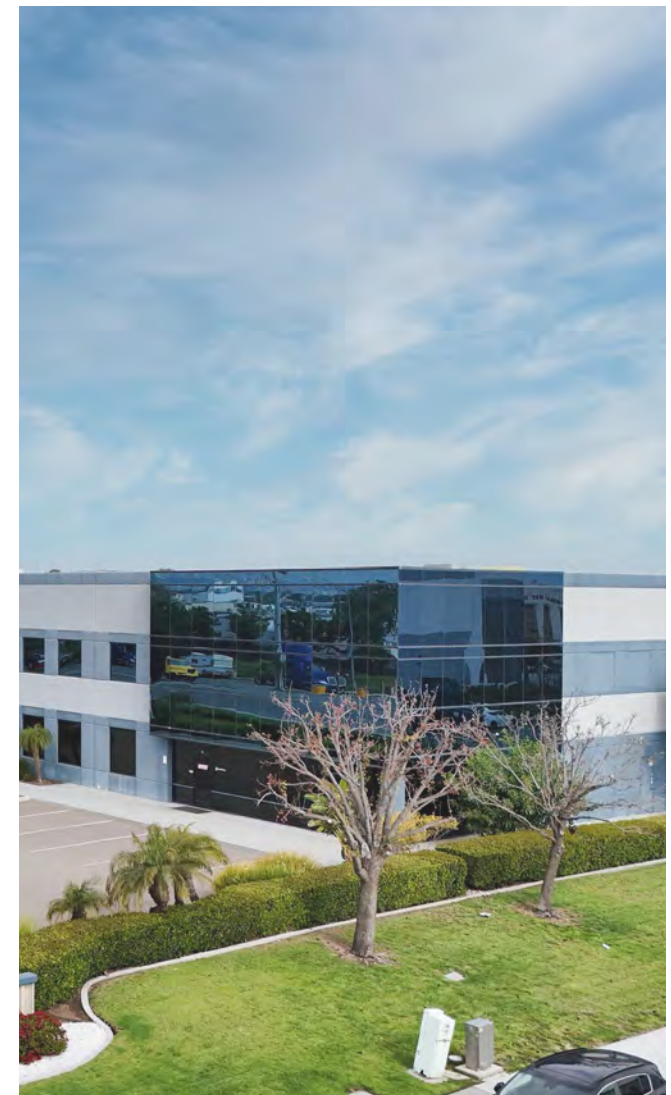
