## **Washington Park**


Following a transformative \$48 million renovation and expansion, Washington Park welcomed enthusiastic crowds at its grand reopening in July 2012. Now attracting millions of visitors annually, this vibrant public space hosts over 400 diverse events each year—from concerts and markets to fitness classes and children's activities. Washington Park has evolved into a true community cornerstone where people gather to relax, play, connect with loved ones, and experience the unifying spirit that defines Cincinnati's urban core.

### Cincinnati Music Hall

Cincinnati's Music Hall, an 1878 Victorian-gothic landmark, anchors the city's cultural identity as home to the Cincinnati Opera, Symphony Orchestra, May Festival, and Ballet. This versatile venue has hosted everything from presidential conventions to performances by Frank Sinatra and Bruce Springsteen. Following extensive 2017 renovations, this reportedly haunted historic treasure now stands as the centerpiece of Over-the-Rhine's urban renaissance, surrounded by vibrant cultural institutions and the revitalized Washington Park, ensuring its place in Cincinnati's cultural landscape for generations.

### **TQL Stadium**

Home to FC Cincinnati, Cincinnati's professional MLS soccer team. Founded in 2015 this franchise began as a United Soccer League (USL) team in 2016. The club has evolved from a lower-division startup to one of MLS's premier organizations, currently playing at the award-winning TQL Stadium (opened in 2021).








