
The Merrill Lynch Building is a premier Class A Office Building situated in the heart of La Jolla at the corner of Fay Avenue and Silverado Street.

The property is located in an amenity rich area which includes luxury shopping and world class hotels and restaurants.





FAY AVENUE I FIRST FLOOR








FAY AVENUE I SECOND FLOOR


