The tenant continues to invest in ongoing improvements (new HVAC, elevator, restrooms, and internal finishes), ensuring the property remains competitive and functional. The comprehensive medical facility offers a full spectrum of healthcare services including urgent care, imaging, family medicine, dermatology, integrative medicine, pain management, internal medicine, and pediatrics, serving the growing communities southwest of Milwaukee. The clinic strategically supports Aurora's new 130,000 sf specialty clinic and surgery center at 9000 Sura Lane, Greenfield, and Aurora St. Luke's Medical Center, a 741-bed acute care hospital located just four miles away across Interstate 43, creating synergies within Aurora's integrated healthcare network. The surrounding area is experiencing significant residential and commercial growth with new apartment developments and the redevelopment of a vacant Boston Store, further strengthening the demographic foundation for this essential healthcare asset.







Lower Level




First Floor




