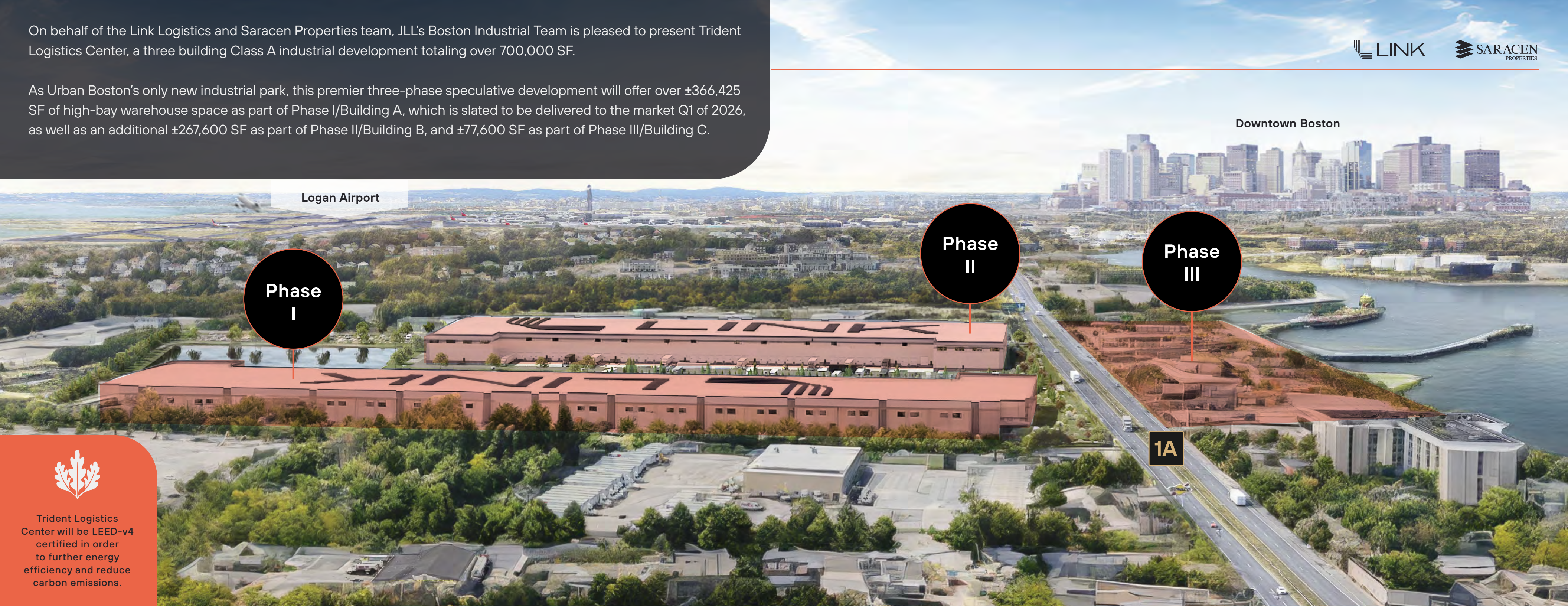

As Urban Boston's only new industrial park, this premier three-phase speculative development will offer over ±366,425 SF of high-bay warehouse space as part of Phase I/Building A, which is slated to be delivered to the market Q1 of 2026, as well as an additional ±267,600 SF as part of Phase II/Building B, and ±77,600 SF as part of Phase III/Building C.



Trident Logistics Center will be LEED-v4 certified in order to further energy efficiency and reduce carbon emissions.

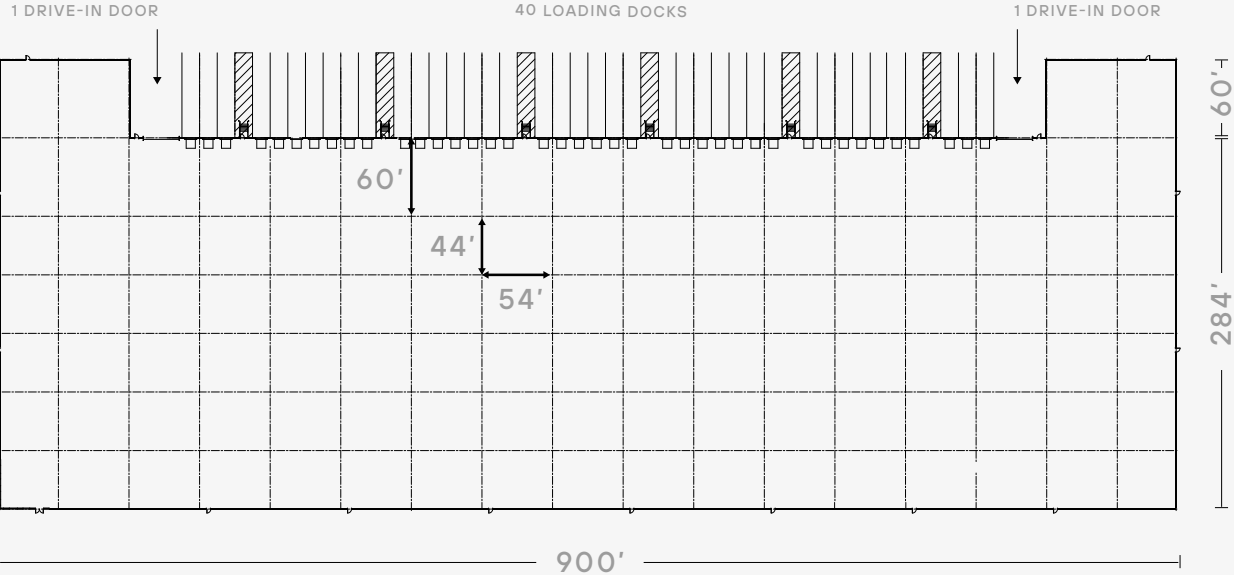
