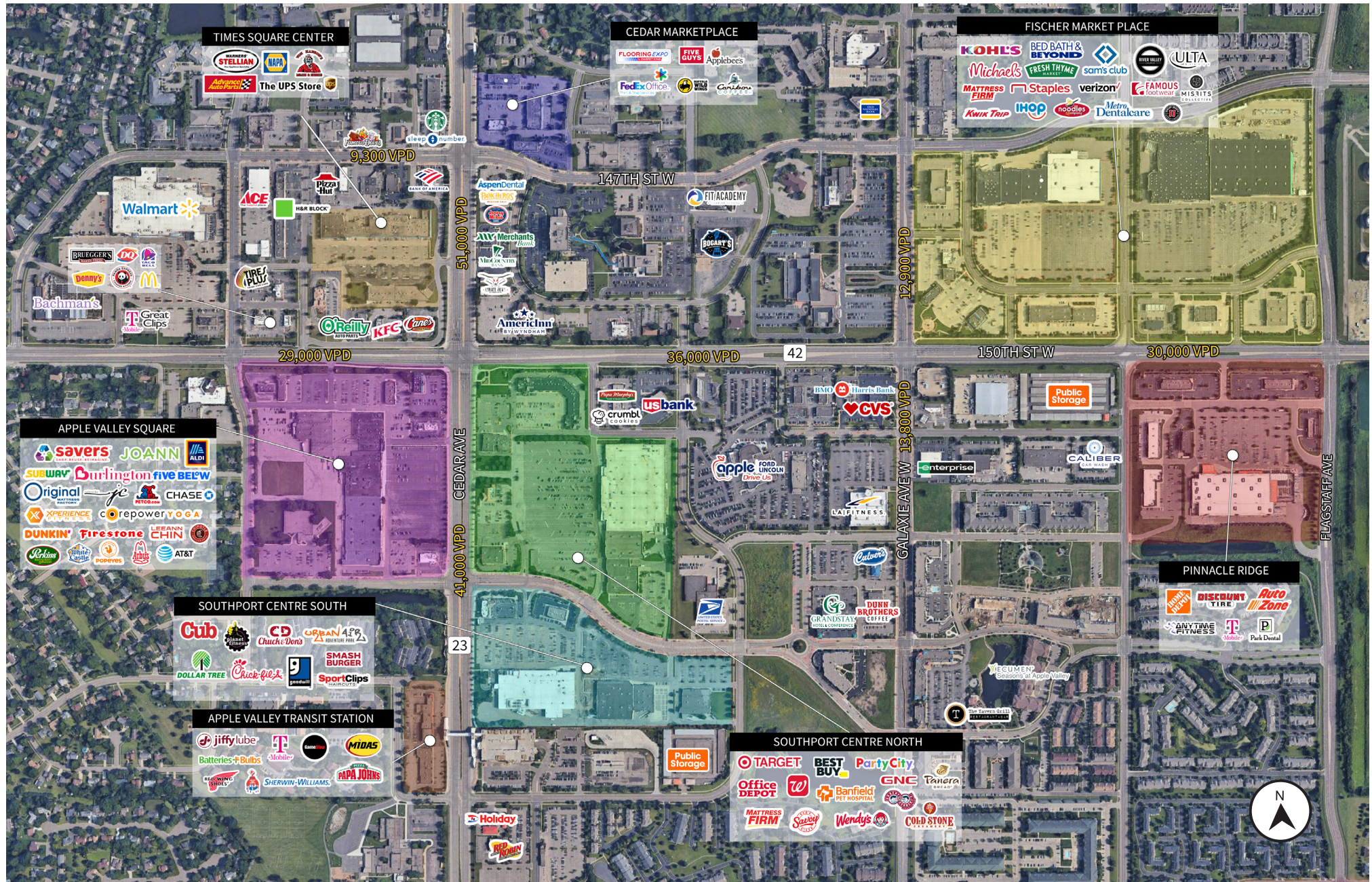


Site plan
