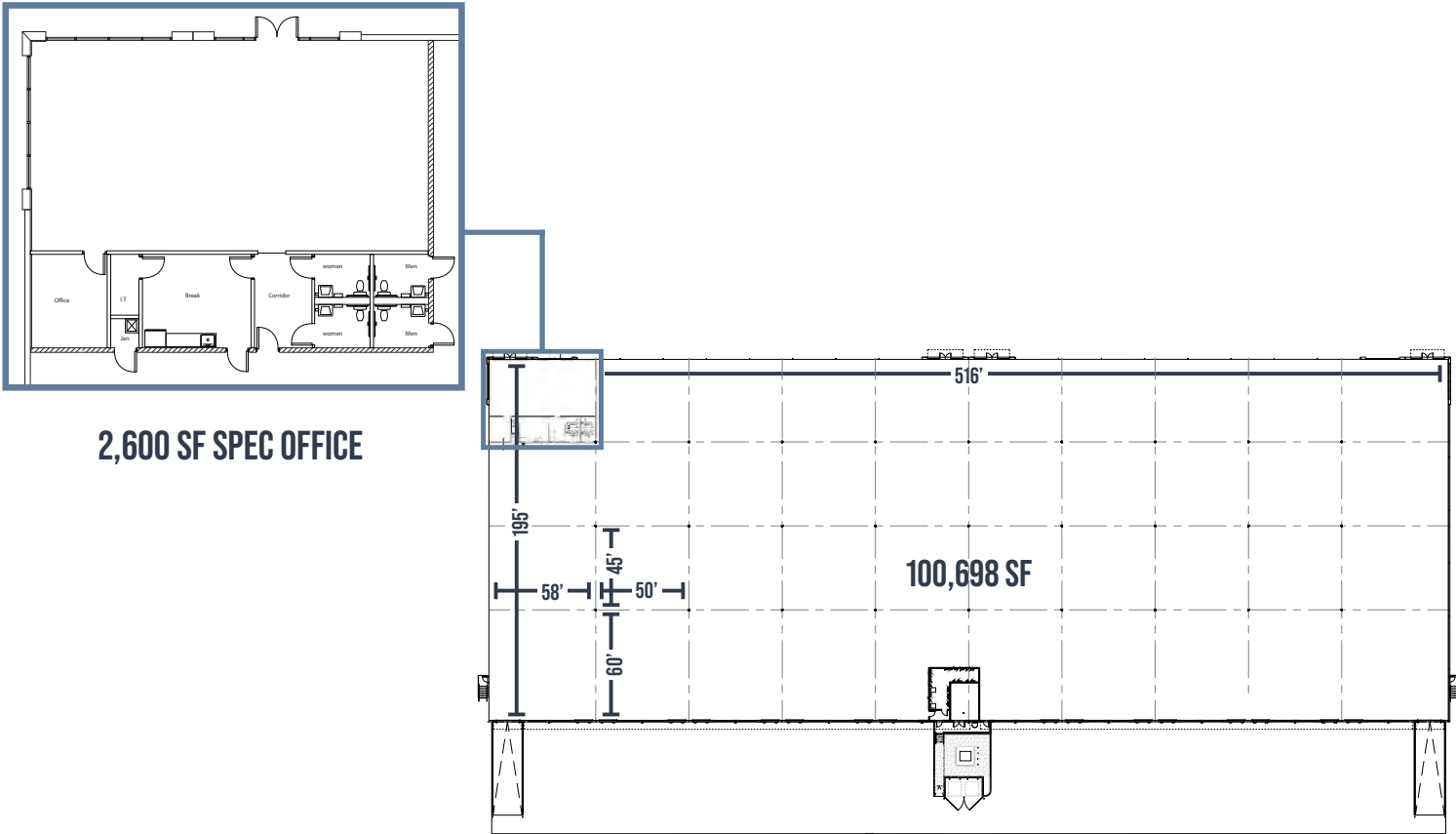

SITE PLAN

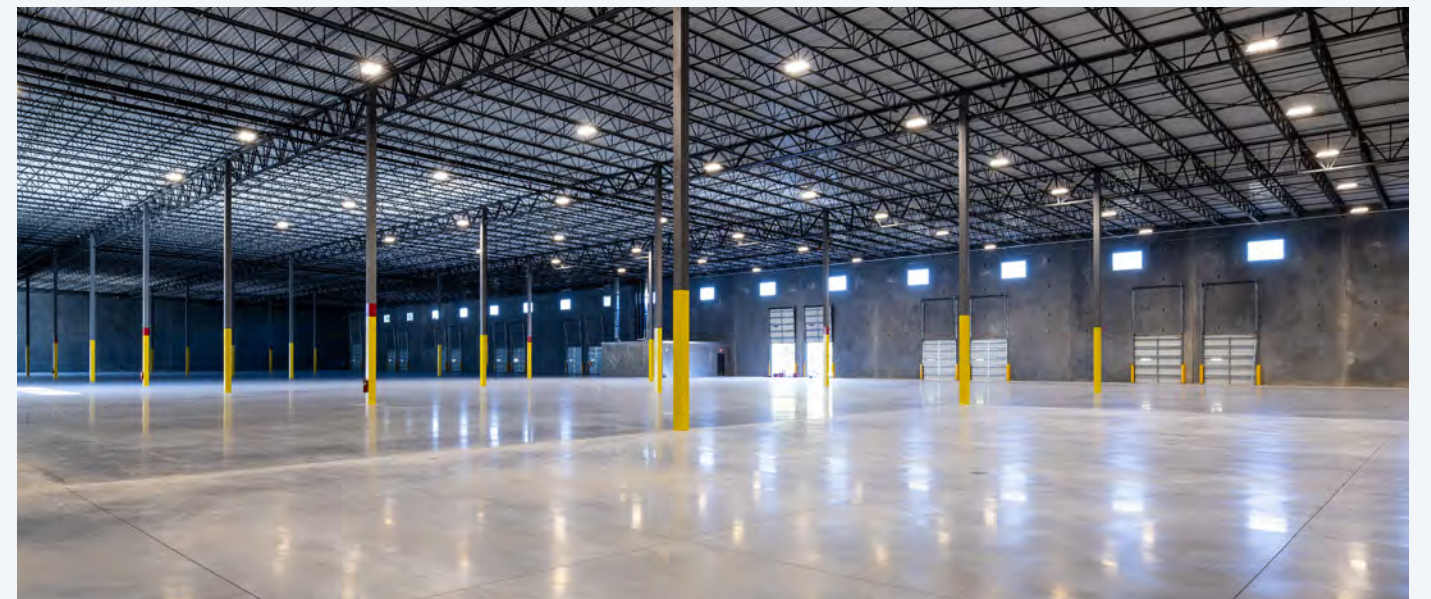


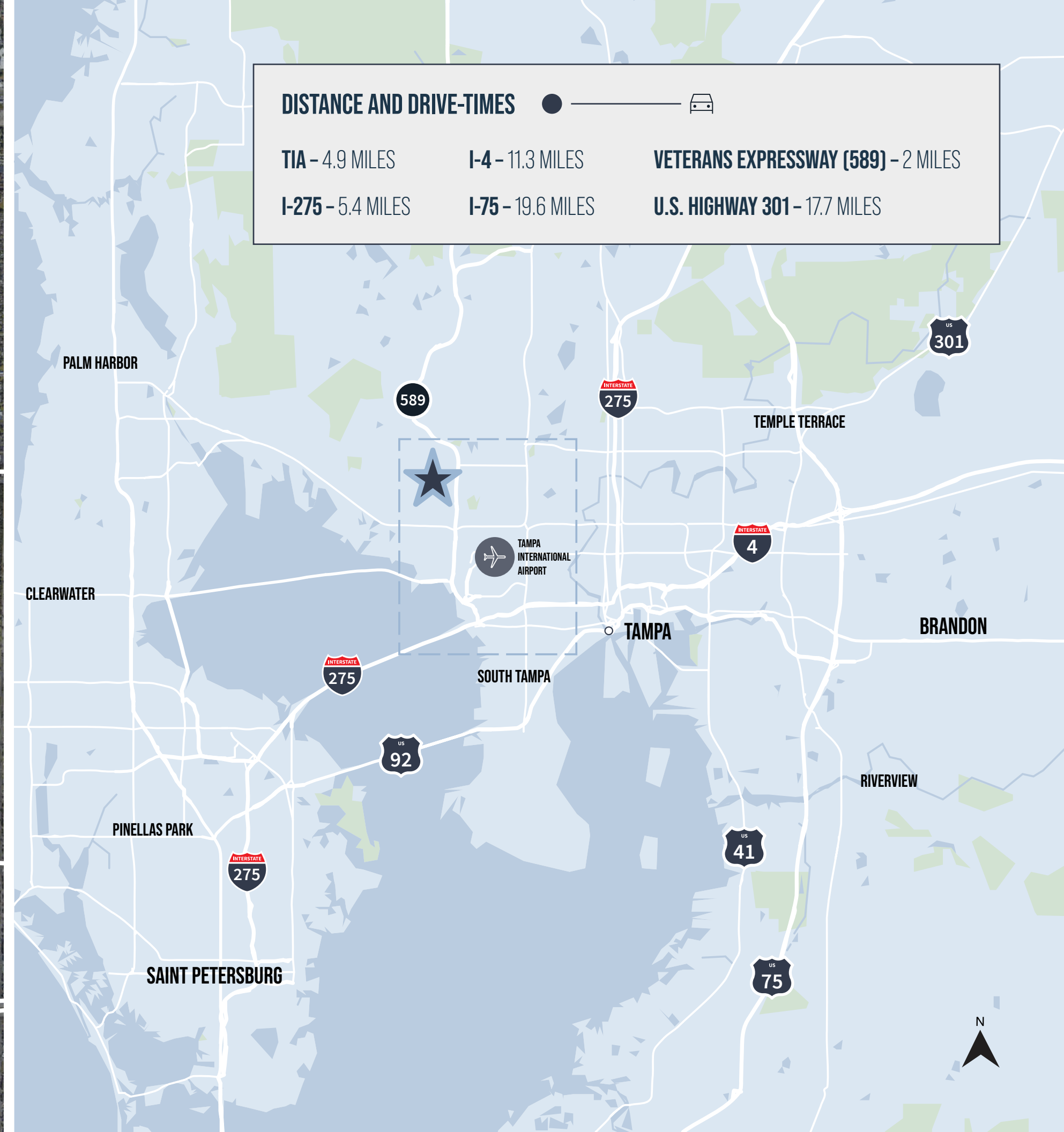
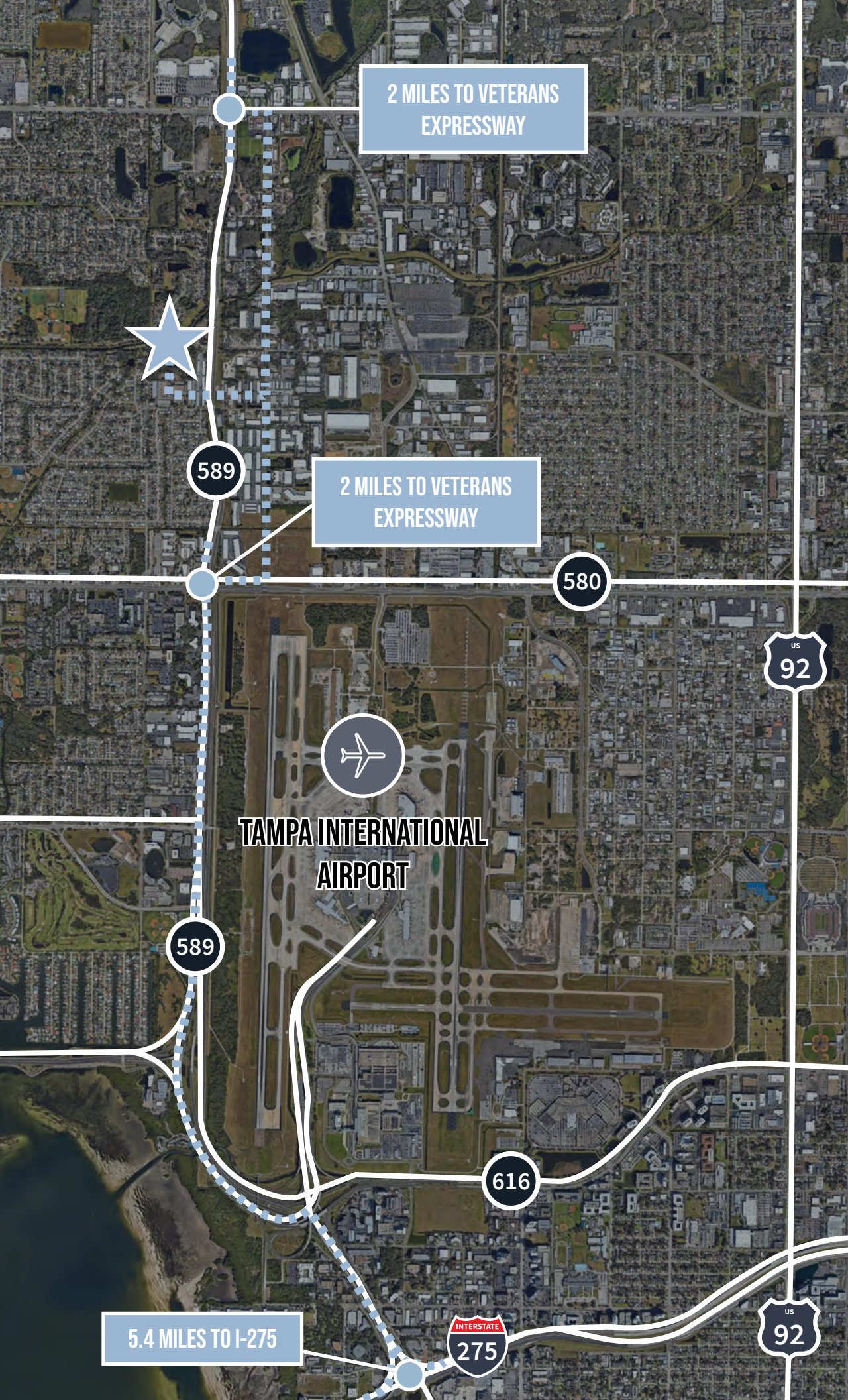
