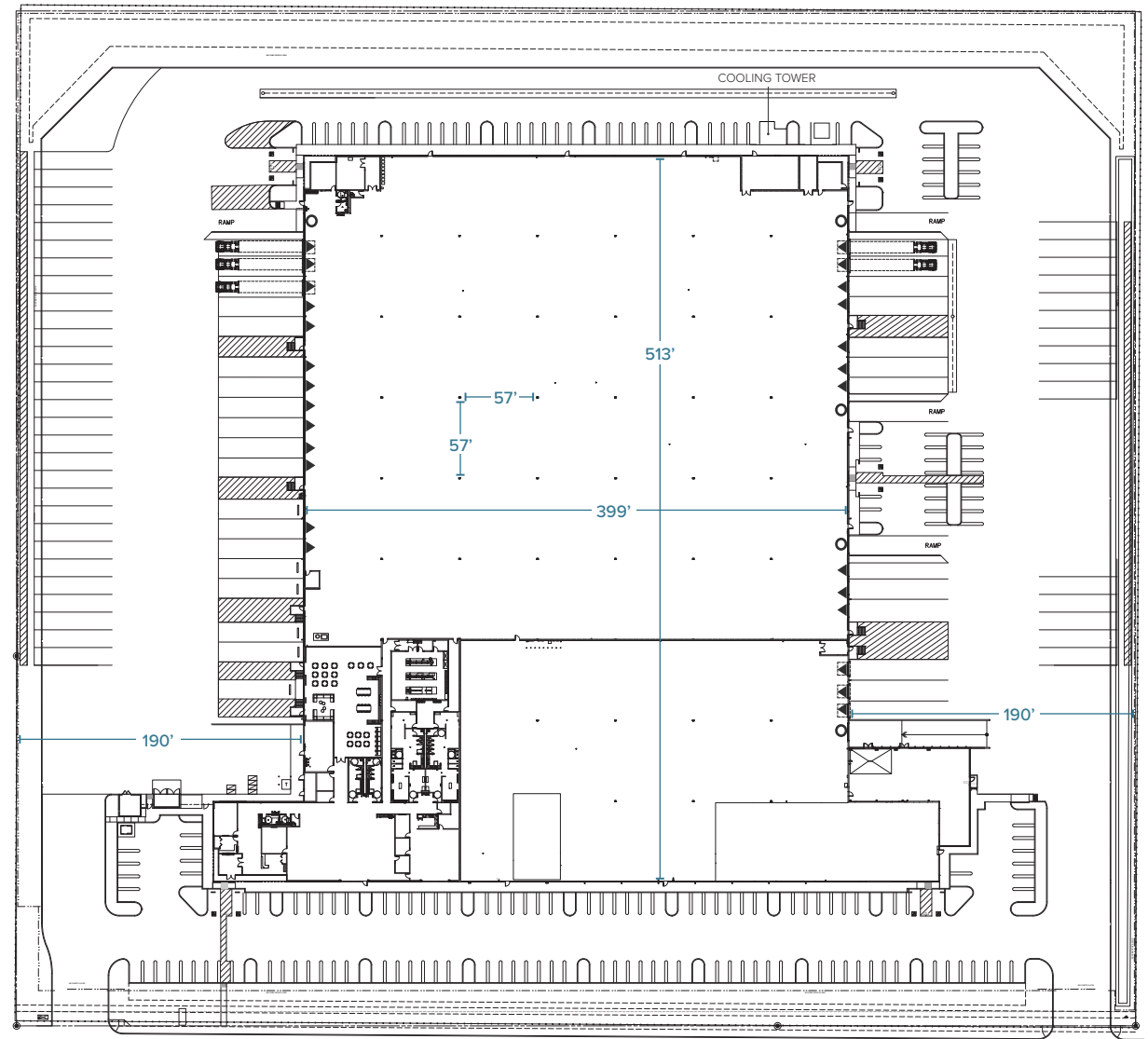

FLOOR PLAN

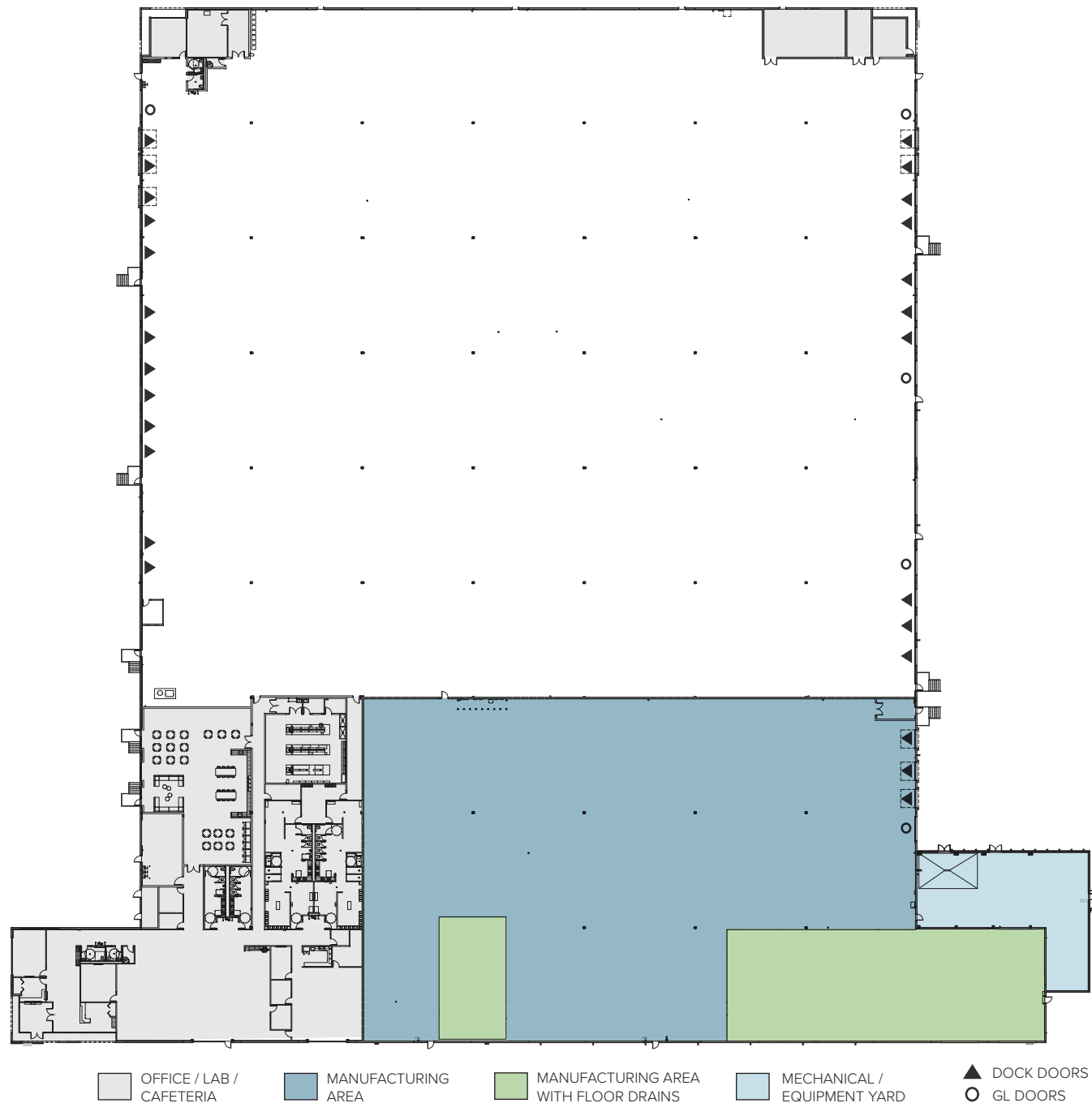

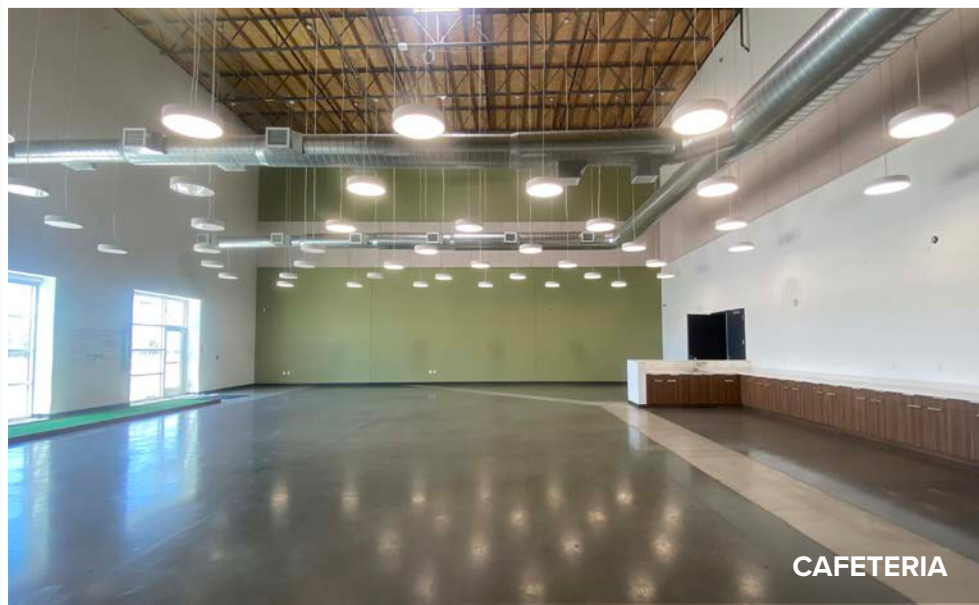

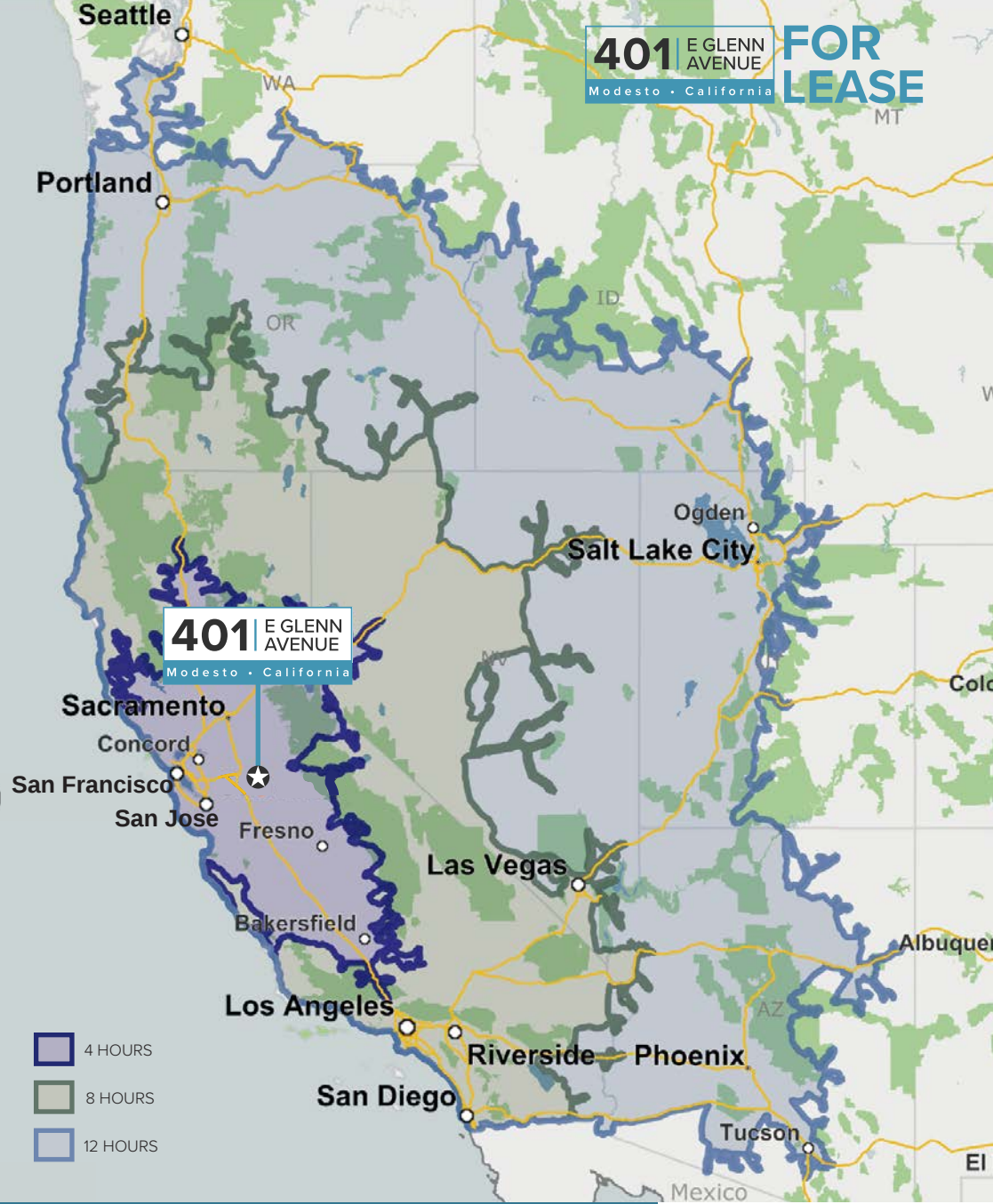
