600-650 LEBEAU BOULEVARD

Available Q3 2026, 600-650 Lebeau Boulevard delivers approximately 73,000 square feet of industrial space designed for operational flexibility. The facility features two clear height: 16 feet in the front section ideal for production operations, and 24 feet in the rear optimized for warehousing, which can accommodate diverse industrial requirements. An existing 5,000 square foot mezzanine provides additional functional space. The zoning permits single or multi-tenant configurations.

Strategic Location & Connectivity: Positioned along Lebeau Boulevard in a mature industrial corridor, the property offers premium visibility with excellent signage opportunities. The location provides comprehensive transportation connectivity with immediate access to Highways 15 and 40, proximity to Montréal-Pierre Elliott Trudeau International Airport, and public transit service including walking distance to the new REM Côte-de-Liesse station.

Additional Facility Details: The facility currently features four loading docks accommodating 53-foot trailers, with the landlord willing to add additional doors based on tenant requirements. Ample on-site parking supports both employee and operational needs.

Amenities & Lifestyle: Employees benefit from proximity to comprehensive retail and service amenities including Marché Centrale, Rockland Center, and Royalmount Mall (12 minutes), supporting workforce attraction and retention.




