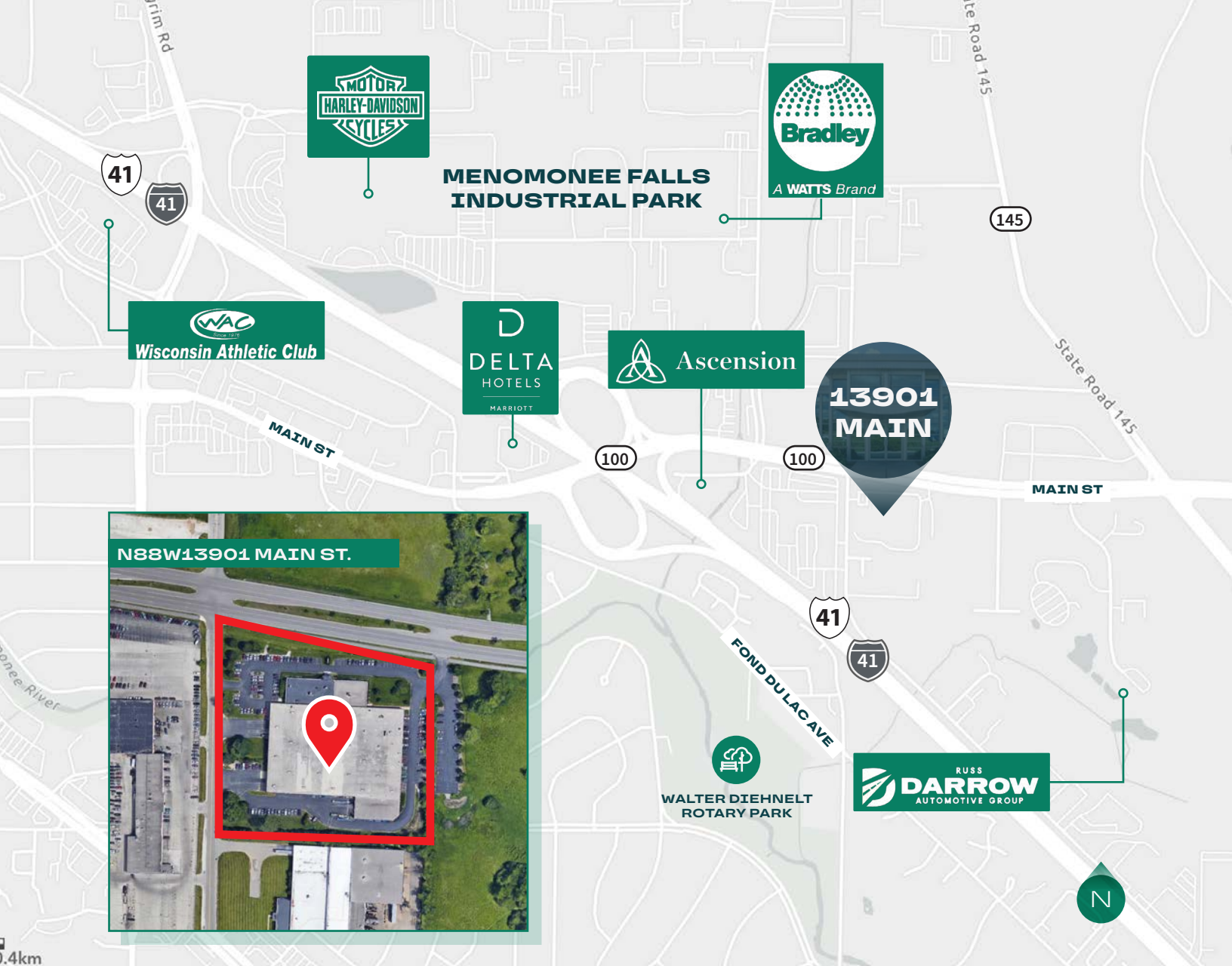

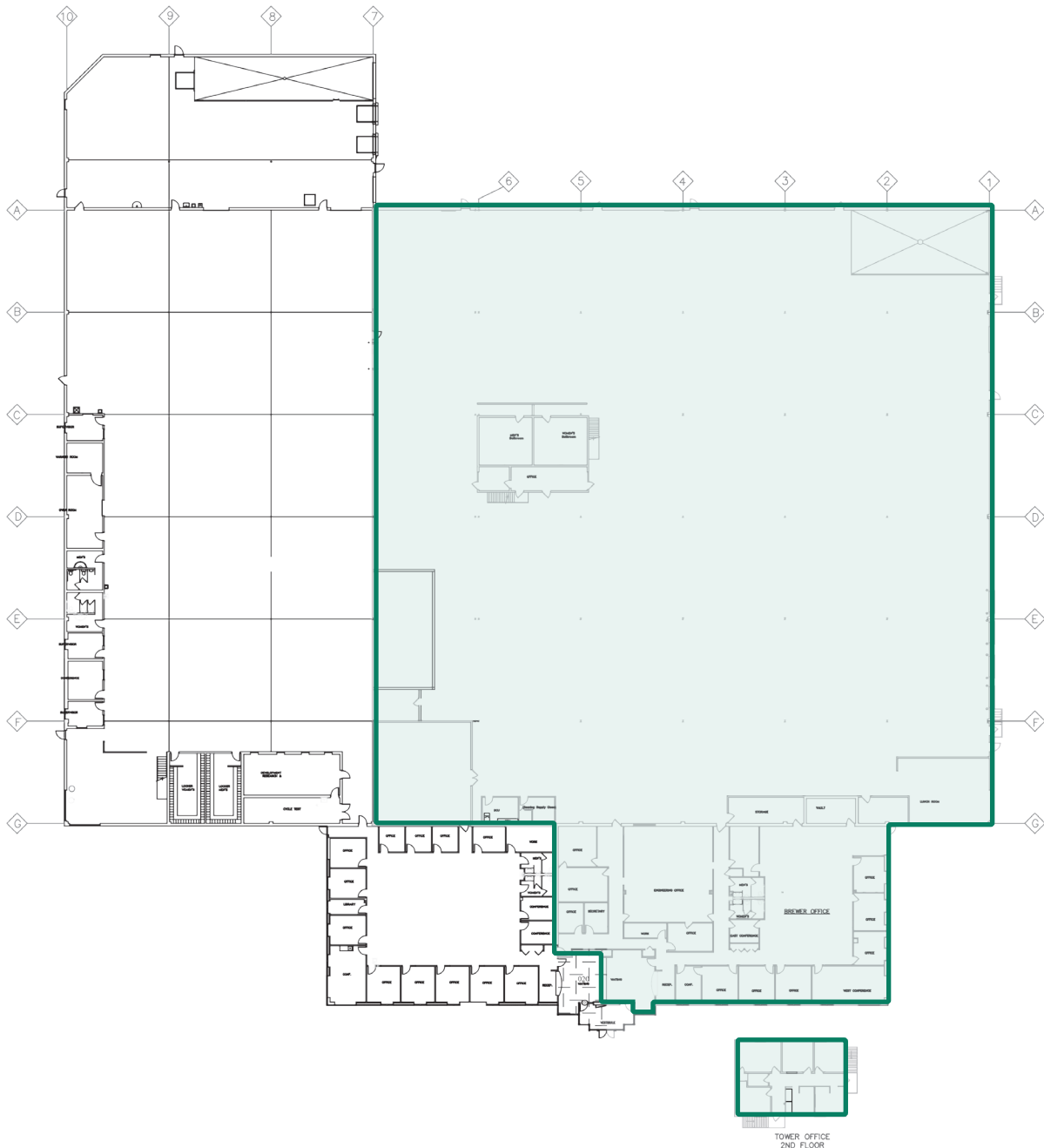
Highway-Adjacent with Retail Convenience

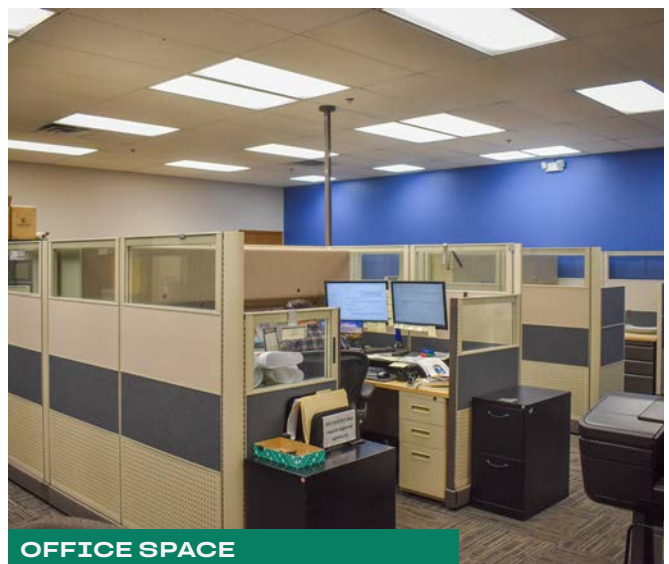

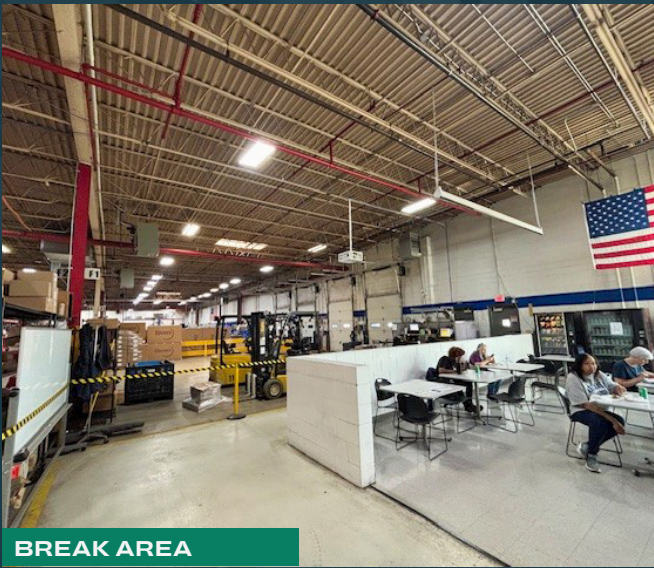
