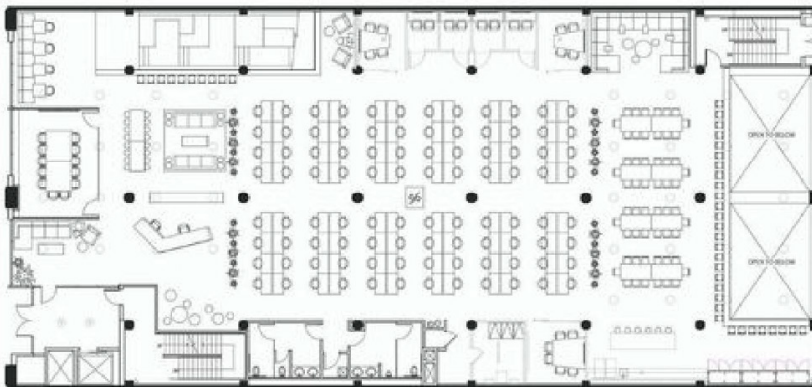

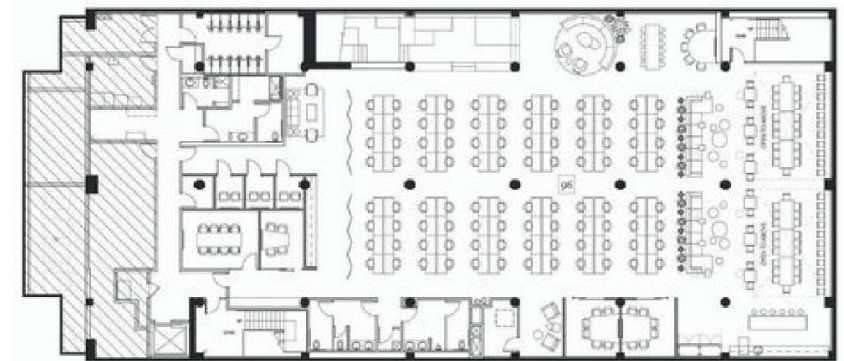
SECOND LEVEL – 13,403 SF



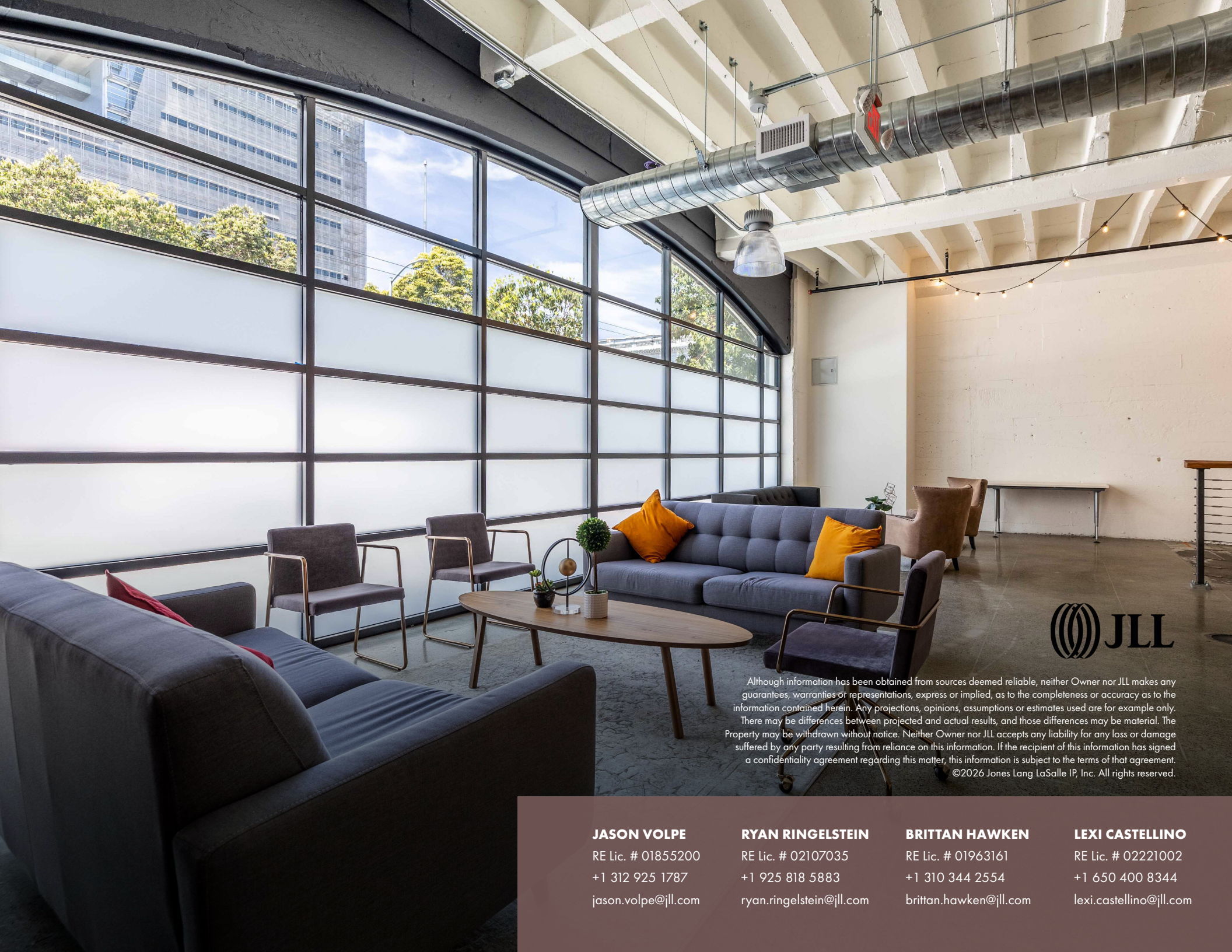
