# EXECUTIVE SUMMARY

Jones Lang LaSalle Real Estate Services Inc. (herein referred to as “JLL” and/or the “Advisor”) has been retained by Rona Inc. (the “Vendor”) to offer for sale a premium commercially zoned parcel of land in St. Catharines, ON, municipally comprised of six (6) pin numbers (the “Property”).

St. Catharines is the largest city in Niagara Region with a 2024 population of ~ 139,000. Situated ~ 112 KM south of Toronto via the QEW with access to the US via the “Queenston-Lewiston Bridge (22 KM to the east) and or the Peace Bridge in Fort Erie (48 KM to the south).

The ~ 14.02-acre Property is designated “Commercial” in the Official Plan and zoned “C4 - Major Commercial”. The Property is well located in a major retail node on the west side of Vansickle Road between the Niagara Health - Marotta Family Hospital to the west, the “Smart Centres - St. Catharines West” power centre to the east; just south of Fourth Avenue. The retail node is anchored by Walmart, Canadian Tire, Real Canadian Superstore and further complimented by notable national tenancies such as BestBuy, Dollar Tree, Farm Boy, Princess Auto, Shoppers Drug Mart, The Brick, Golf Town and Tepperman’s Furniture, creating and ideal location for future commercial development.

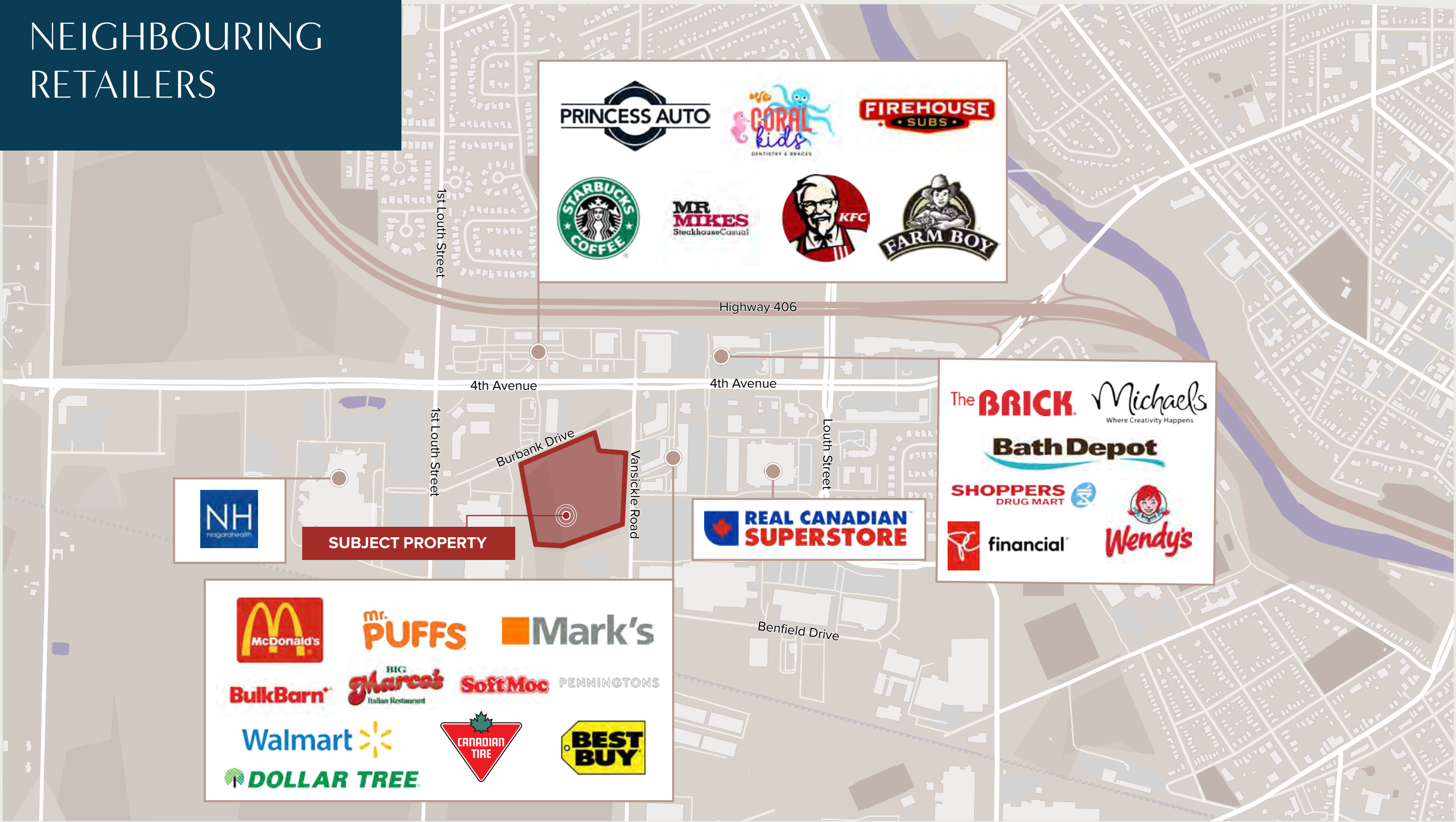
