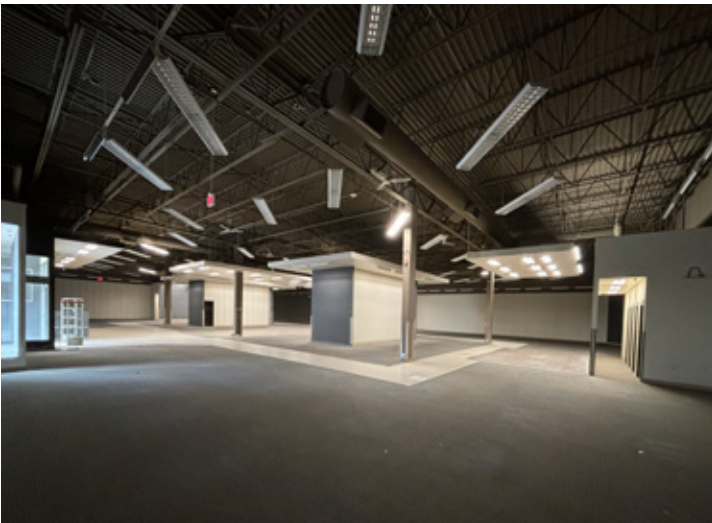

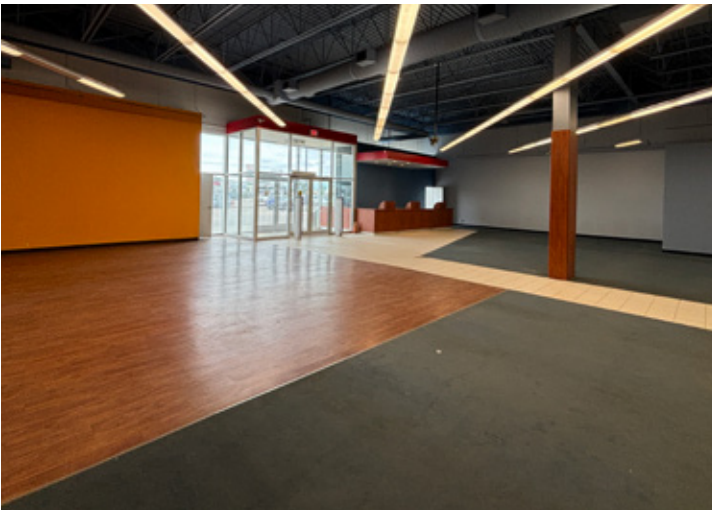


Property Photos - Interior
