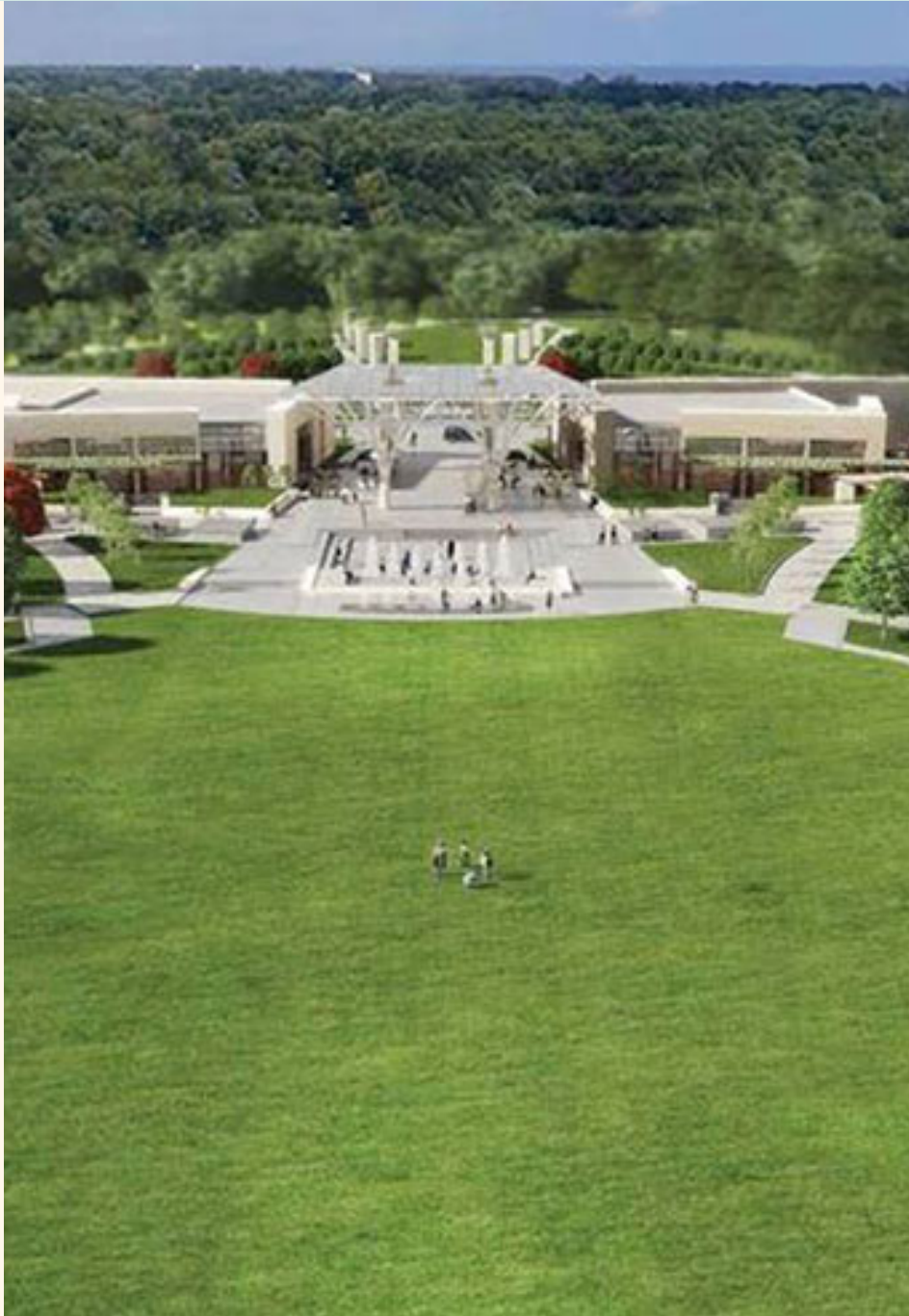

SUMMIT PARK SPANS

130 acres of premier parkland, anchored by a community pavilion and event venue alongside cafes, bistros, a grand performance stage, and an observation tower. Winding walking paths traverse open meadows, complemented by interactive programming and seasonal experiences throughout the year.

The development encompasses five distinct districts—The District, Carver Woods, Parkside, Daventry, and Summit Park—each designed to support working, dining, shopping, living, and recreation. The Neighborhoods at Summit Park deliver luxury apartment residences and single-family homes that blend urban sophistication with access to the region's premier school districts.

Summit Park's amenities extend beyond the central green to include the Woodland Nature Preserve, Northeast Market Pavilion and Wine Garden, multiple playgrounds, a nature playscape, skate park, and sledding hill. Environmental features such as a rain-harvesting lake and water feature enhance the landscape, while dog parks, trail systems, and picnic areas provide additional gathering spaces for residents and visitors.

Move-in ready tenant spaces showcase high-end finishes and modern design elements, enabling prospective occupants to envision their workspace within a polished, professional environment.

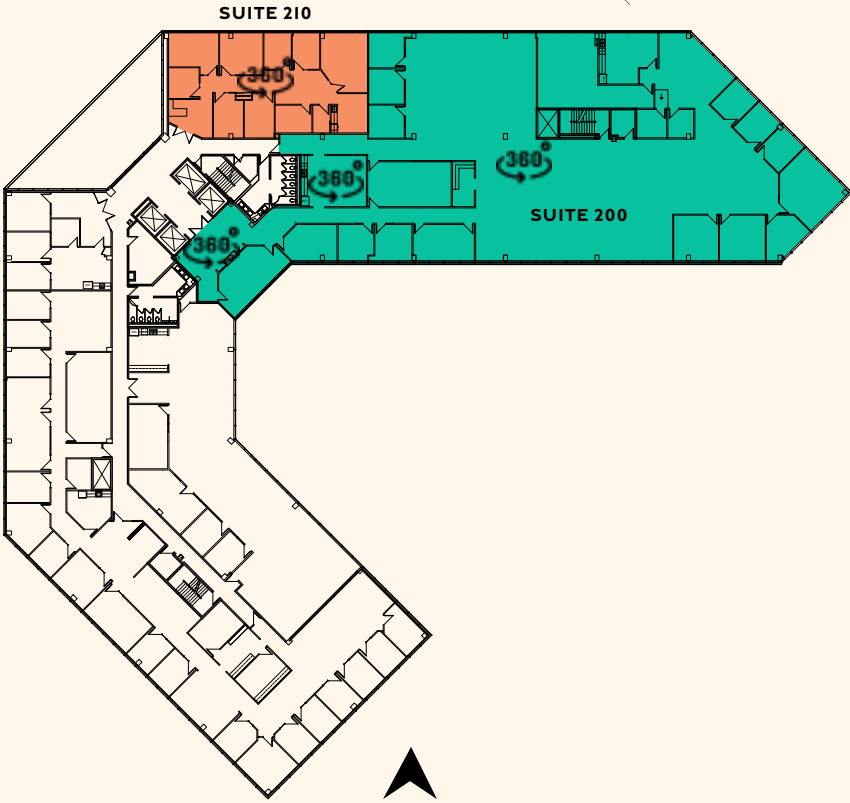

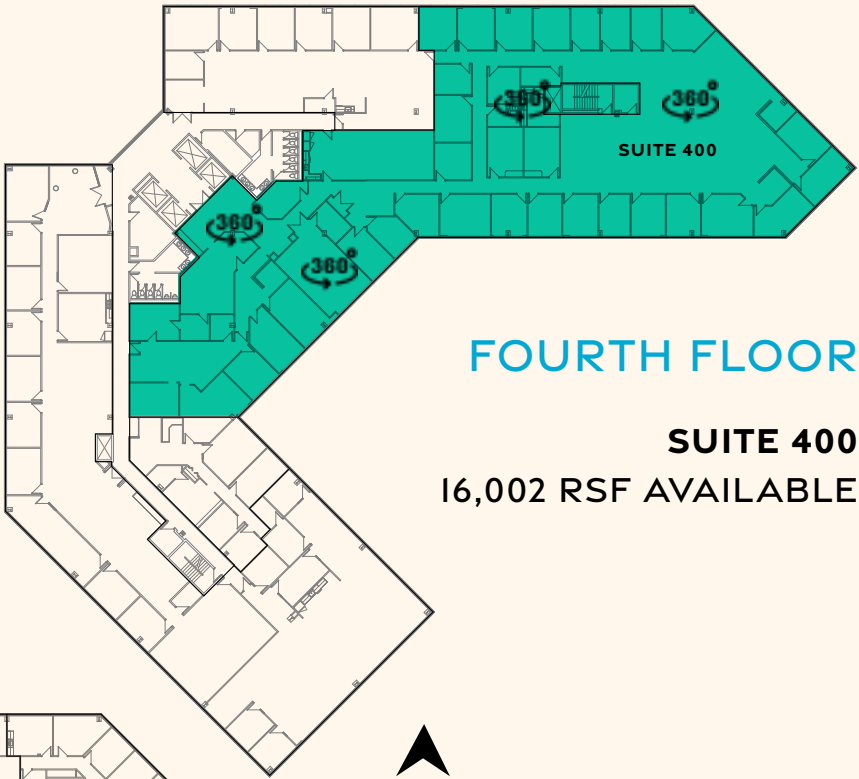

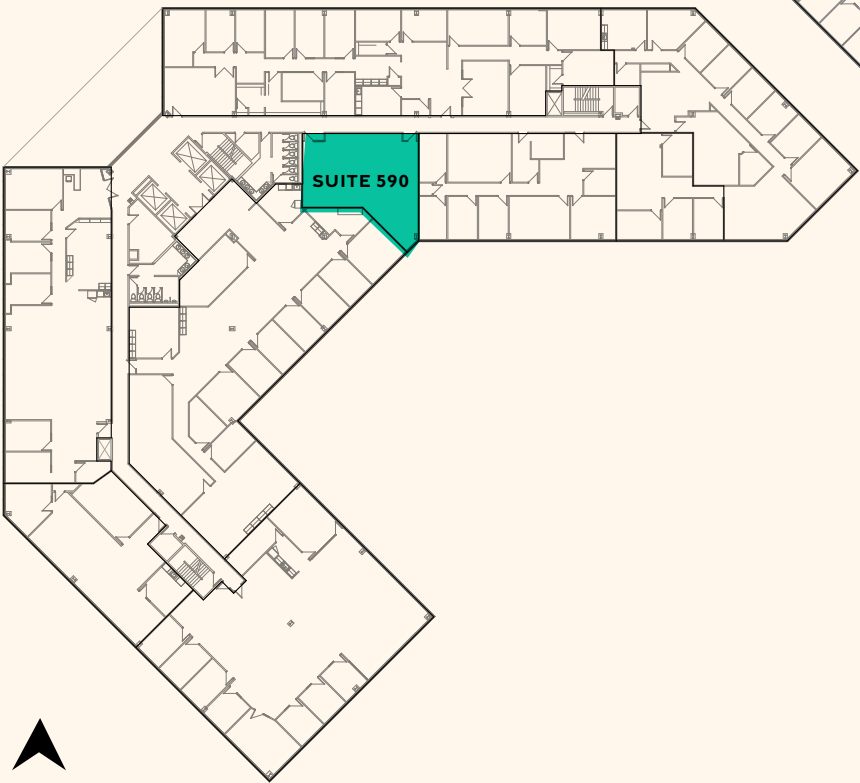
