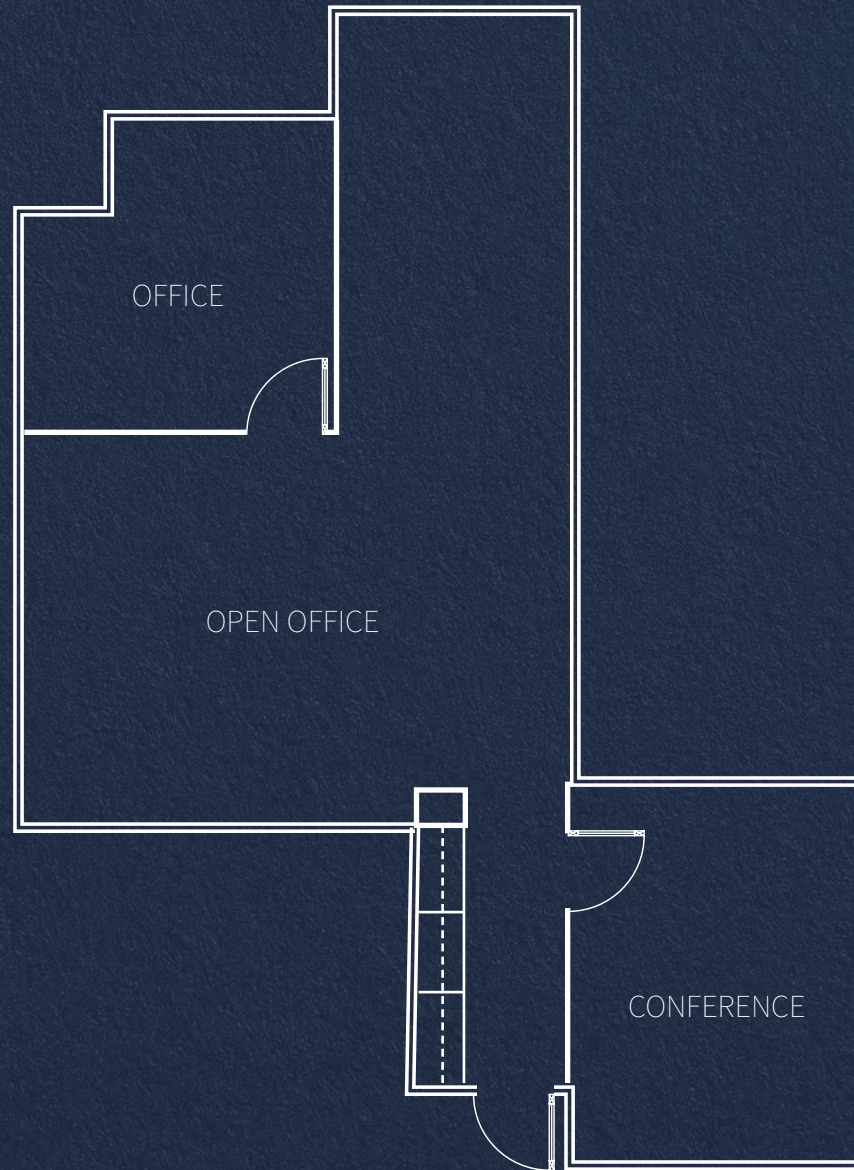

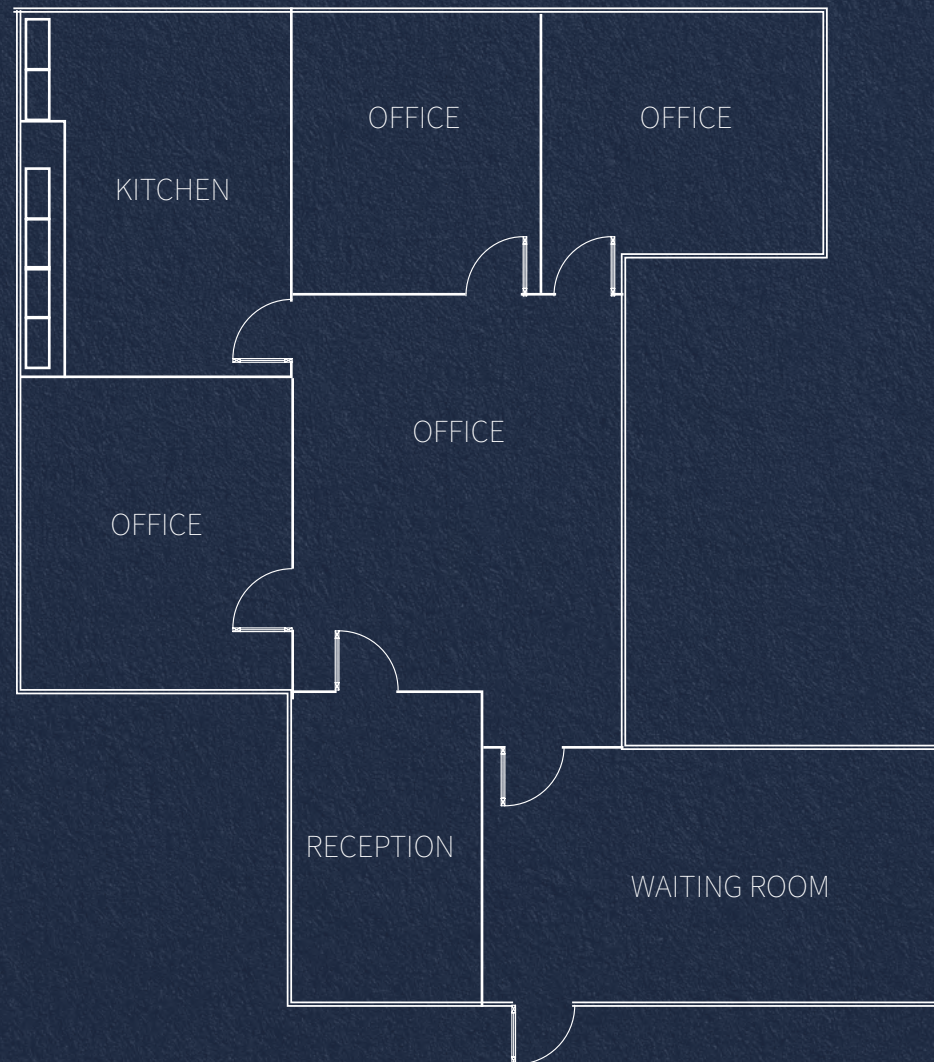
FLOOR PLAN

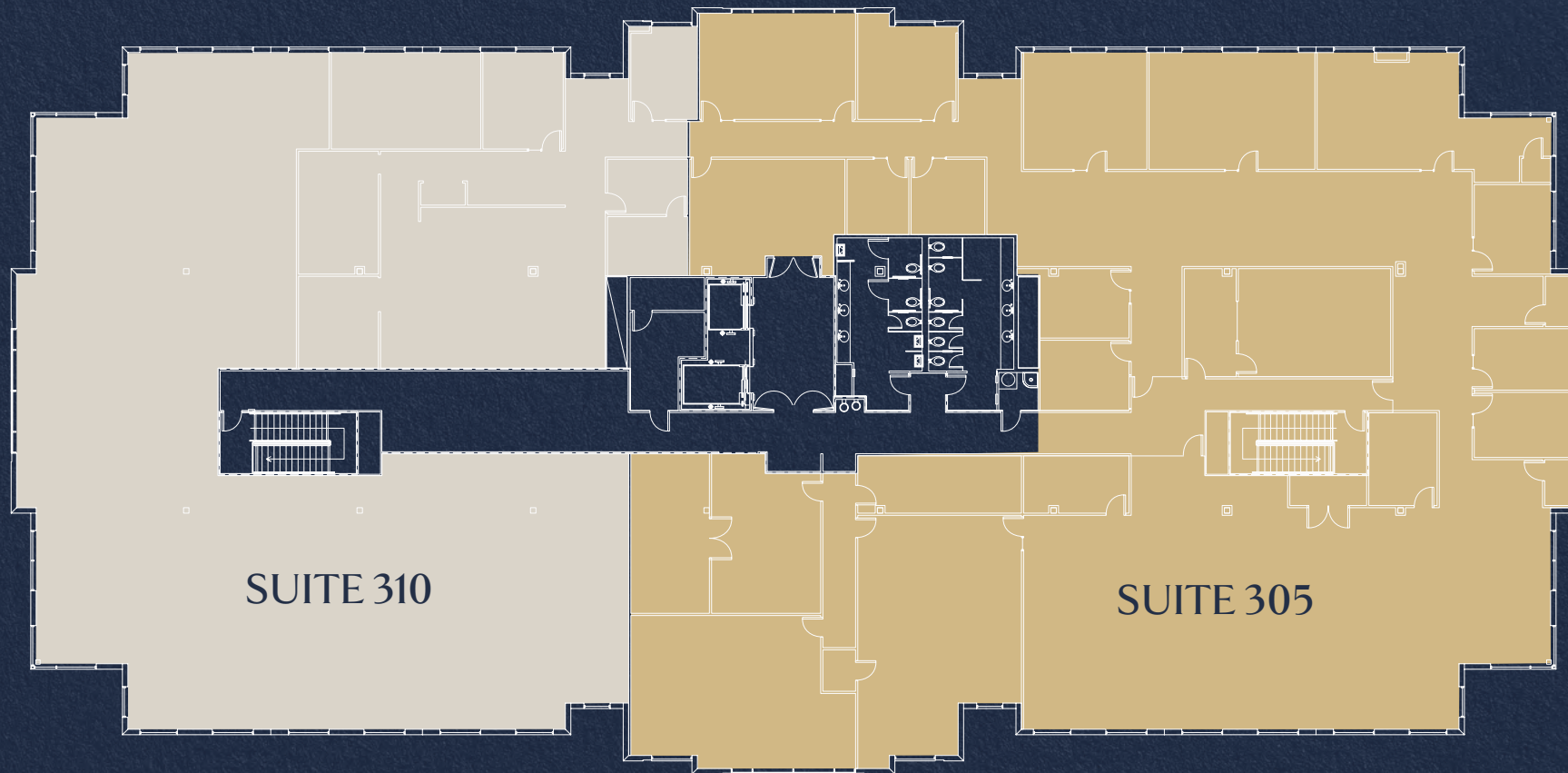

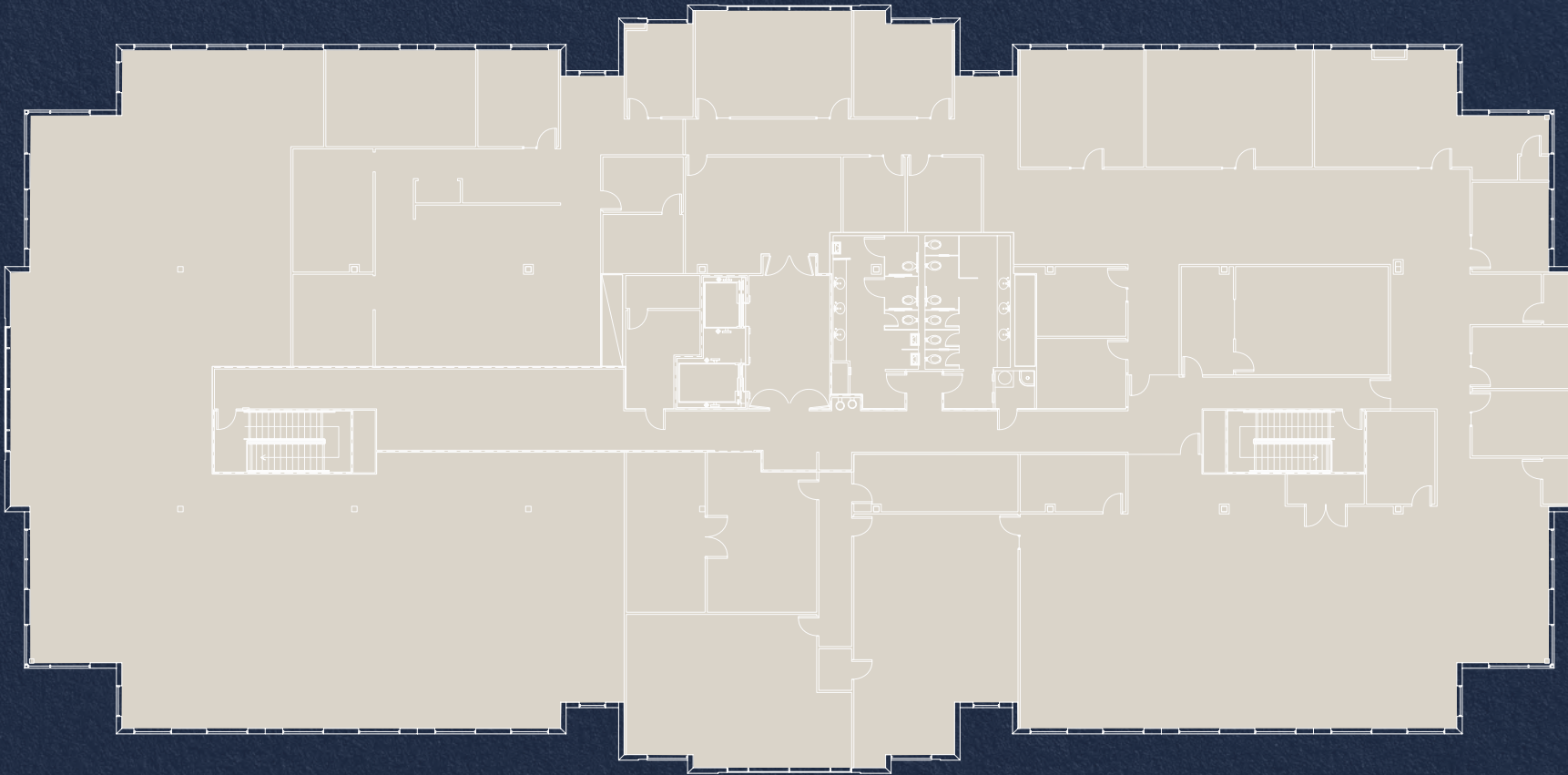
