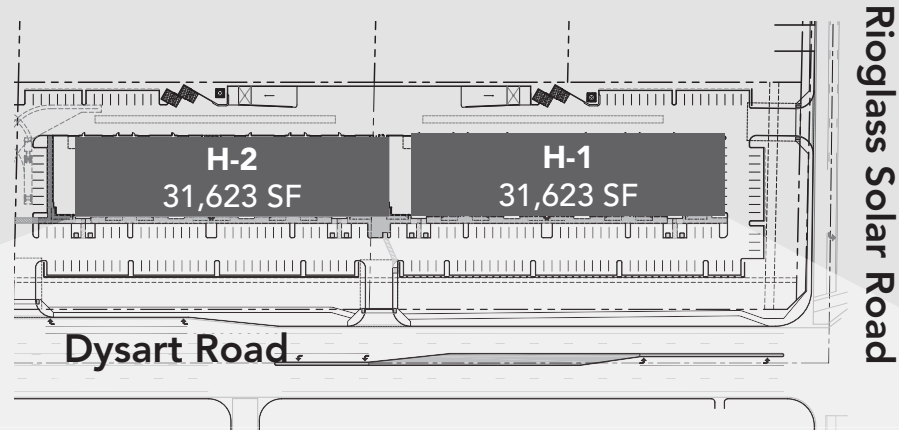
LOCATION FEATURES

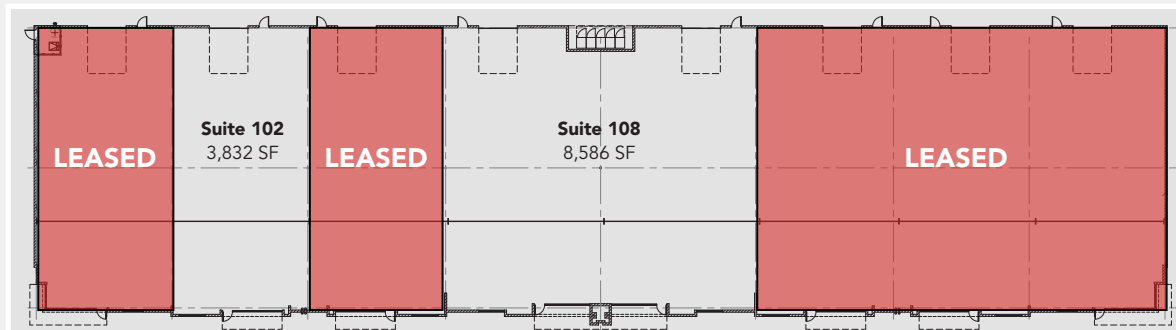

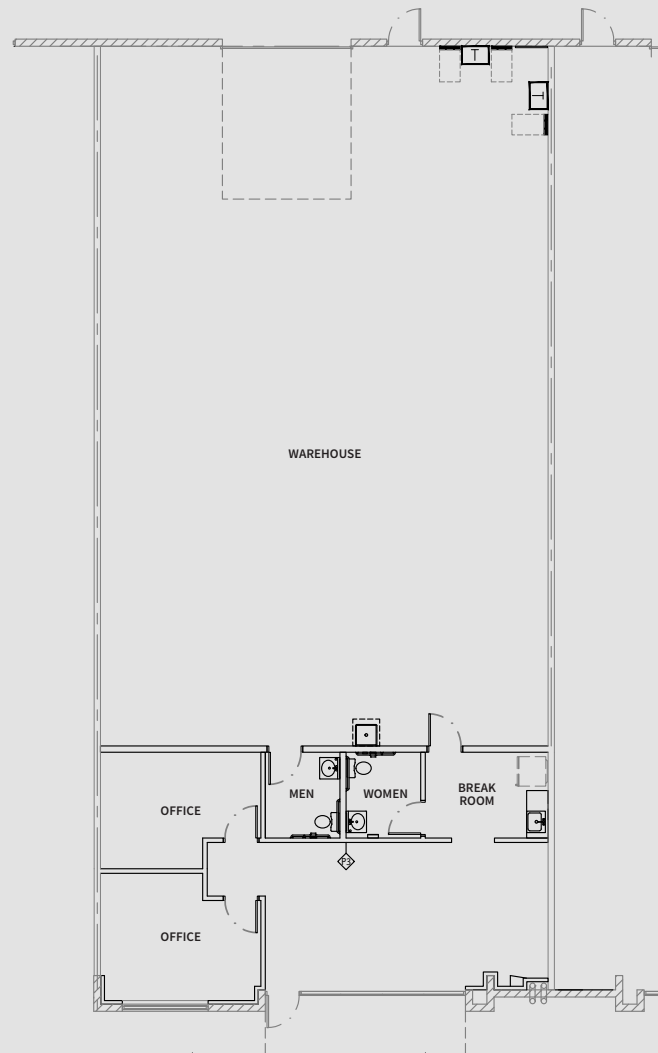

BUILDING H-1 | SUITE 102 FLOOR PLAN

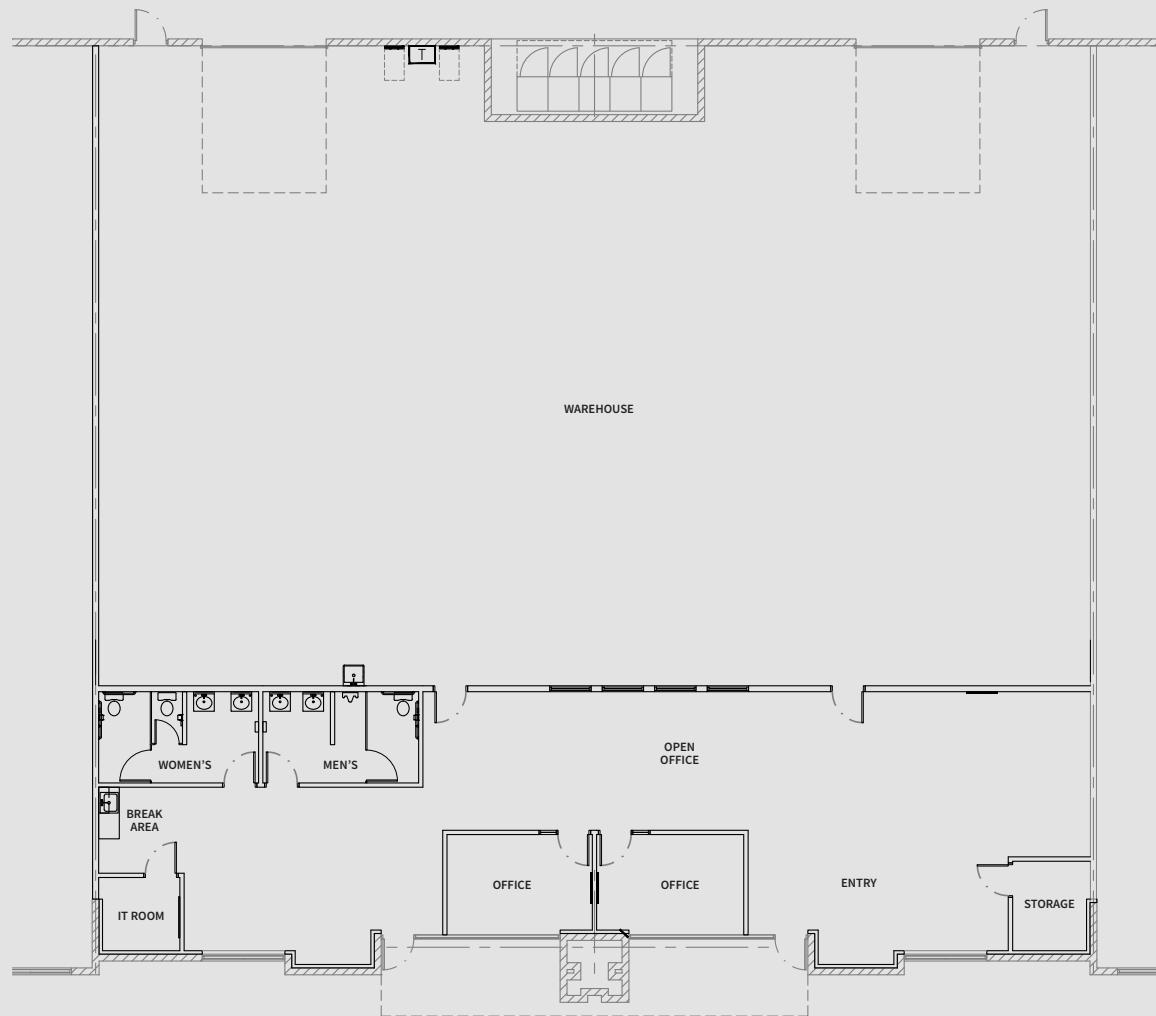

BUILDING H-1 | SUITE 108 FLOOR PLAN

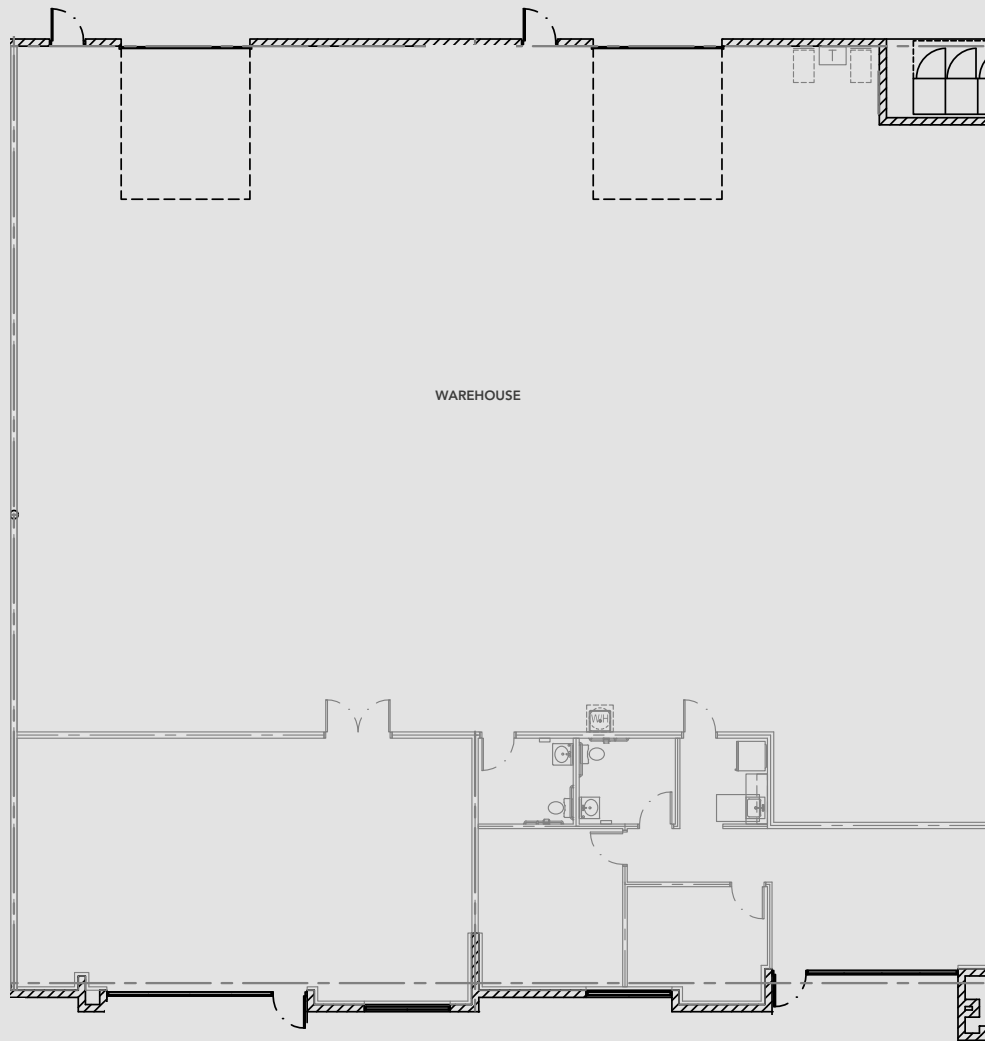
