

Terms and Conditions of "Visit Japanese swordsmiths in Okayama and enjoy the regional art festival in Niigata Online Tour"

- This event is organized by the Japan National Tourism Organization ("JNTO") for those who live in English-speaking countries ("Participant").
- Participant is required to abide by these Terms and Conditions in participating in this event. Participation in the event shall be considered as the Participant's agreement to these Terms and Conditions. JNTO will use the personal information provided by the Participant for marketing and promotional purposes with the Participant's consent.
- The event will begin at 7:30 PM (EST) on Saturday, November 26, 2022, and will be accessible to participants 10 minutes prior to the start of the event.
- All participants must be 18 years of age or older.
- A quiz event will be held during the livestream asking two questions.
Participants will be able to answer the quizzes through the Facebook Live chat room.
Comments left during and after the livestream will not be aggregated.
- Of all the participants who answer the quiz correctly, two will be randomly chosen and will be gifted an "Amazon gift card worth \$70".
- In the quiz game, each person will only be allowed to answer once for each question.
- Neither JNTO nor the contractors of this project are eligible to participate in the quiz events. To ensure fairness, any participant who belongs to any of these organizations will be disqualified.
- The 1st to 5th, the 10th, the 20th, the 30th, the 40th, and the 50th person to answer the survey after the livestream will receive an "Amazon gift card worth \$70".
- The due date/time of the survey is December 3, 2022 at 11:59PM (EST).
- Each Participant can only answer the survey once and may not answer multiple times.
- All prizes are non-refundable, non-exchangeable for cash, and non-transferable.
- Winners will be notified via Facebook message from the campaign's Facebook account (@Facebook account name) or on a separate email from @xxxtsunagaru.co.jp.
- Winners will be notified upon delivery. We will not be announcing the winners on any website or social networking sites.
- Winners will be notified by early December 2022.
- Winners must reply to the email within 3 business days after receiving the email on winning the gift from the campaign office. If the winner does not respond to the message or e-mail after being notified, the winner's eligibility will be forfeited.
- The eligibility for the prize draw will be based on JNTO's media standards. No objection will

be accepted from participants regarding the winners of the quiz.
