To the fullest extent permitted under applicable law, your continued use of the Service after any such modification constitutes your acceptance of these Terms as modified.

Visa may, in its sole discretion, terminate, change, modify, suspend, make improvements to or discontinue any or all aspects of the Service, temporarily or permanently, including the availability of any features of the Service or access to any parts of the Service, at any time with or without notice to you. You agree that Visa shall not be liable to you or to any third party for any modification, suspension or discontinuance of the Service.

You may terminate your use of the Service at any time. In the event of any inconsistency between these Terms and your card agreement with the respective Issuer, these Terms govern as to the relationship between you and Visa solely with respect to the Service and your card agreement with your Issuer governs as to the relationship between you and your Issuer.
- 6. <u>Indemnification</u>. - 9. <u>Disputes.</u> Visa and you agree that any and all disputes, claims and causes of action arising out of or in connection with these Terms or the Service shall be resolved exclusively within the courts in

- Singapore, and Visa and you each waive any jurisdictional venue or inconvenient forum objections to such courts.
- 10. <u>Relationship of the Parties</u>. Nothing in these Terms will be construed as creating a joint venture, partnership, employment or agency relationship between you and Visa, and you do not have any authority to create any obligation or make any representation on Visa's behalf.
- 11. <u>Assignment</u>. You may not assign these Terms by operation of law or otherwise, without Visa's prior written consent. Visa reserves the right to freely assign these Terms, and the rights and obligations hereunder, to any third party without notice or consent. Subject to the foregoing, these Terms will be binding on, inure to the benefit of, and be enforceable against you and your respective successors and assigns.
