



Sponsorship Agreement Contract 2016

December 29th, 2015

Molina Healthcare Foundation agrees to provide Wonder Women Tech Foundation the following in-kind services and/or pay the following fees for a WWT Networking Lounge + Inclusion Career Fair Exhibit Sponsor Package.

In consideration of the agreement by the Sponsor to pay Wonder Women Tech Foundation the sum of \$30,000.00 to sponsor the Networking Lounge and have a booth inside the Inclusion Career Fair, Wonder Women Tech Foundation agrees to provide the benefits set out below.

WWT Networking Lounge + Inclusion Career Fair Exhibit Sponsor Package

Total Due for Package: \$30,000.00

Components of Sponsorship Package:

- Recognition as Networking Lounge Sponsor
- Exhibition module counter for up to 2 sponsor staff members in designated area within Networking Lounge
- Sponsor can assist with design and use of space within Networking Lounge (Sponsor will be responsible for special furniture and buildouts and cover cost of labor and material, handling/drayage at the venue.)
- Opportunity for branded giveaways
(sponsor will be responsible for providing the giveaway item, covering cost of labor and material, handling/drayage at the venue)
- Opportunity to create customized outreach and marketing campaign for special promotions and social media campaigns
- Opportunity to provide speakers or create an 'Innovations in Healthcare' panel or discussion

topic for a panel to be created. Ex: “Molina Healthcare Presents “Innovations in Healthcare”

- Prominent website presence as Networking Lounge Sponsor
- Social Media & Newsletter mentions, including a special Twitter Party Sponsor Spotlight to be scheduled in the months of March and June (Distribute ‘Why Work for Molina Healthcare’ video, etc.)

Wonder Women Tech Foundation may adjust such benefits, substitute benefits or provide other benefits with the approval of the Molina Healthcare Foundation.

Payment Terms: Cash or Check payments are due as follows: 100% percent within 30 days of issuance of this contract. Failure to pay fees when due may result in termination of this agreement. In-kind services shall be scheduled in writing by representatives of Wonder Women Tech Foundation and Sponsor. Checks shall be made payable to Wonder Women Tech Foundation.

Limitation of Sponsorship: Unless otherwise provided, the cash or services and the Sponsor benefits described in this agreement are related solely to the Wonder Women Tech Conference to be held July 15-17, 2016 in Long Beach, California. Assuming the Event is continued in 2017, the Sponsor shall have the first right of refusal to continue Sponsor's involvement in the Event on such terms as Sponsor and Wonder Women Tech Foundation shall agree.

License and Usage: Sponsor hereby grants Wonder Women Tech Foundation a limited, nonexclusive license to use Sponsor's trade names, trademarks, service marks and other proprietary information owned by the Sponsor for any and all purposes related to the 2016 Wonder Women Tech Conference and the Sponsor's sponsorship thereof. Wonder Women Tech Foundation agrees that the Proprietary Information will be used only in connection with Wonder Women Tech Foundation to provide the benefits set forth in the Proposal and such other benefits as Sponsor and Wonder Women Tech Foundation may agree. Wonder Women Tech Foundation's use of the Proprietary Information is subject to the approval of the Sponsor's designated representative, which approval will not be unreasonably withheld.

Sponsor Understandings: Sponsor understands as follows: the dollar values set forth in the Proposal are estimates and based upon general sponsorship information available to Wonder Women Tech Foundation; the audience multiplier is based upon estimates of Wonder Women Tech Foundation attendance and actual attendance figures may vary materially. No portion of the sponsorship cash payment or in-kind services are subject to being refunded for any reason except as provided herein. Sponsorships are not exclusive unless otherwise set forth in this agreement or an addendum to this agreement.

Termination: Wonder Women Tech Foundation, at its discretion, may terminate this contract with 30 days written notice. In the event of termination for any reason other than failure to provide contracted fees or services, Wonder Women Tech Foundation may substitute an event with equivalent benefits with the approval of the Sponsor or shall refund any cash fee received from Sponsor. Sponsor shall not terminate this agreement without the approval of Wonder Women Tech Foundation.

Amendments: This agreement may be amended only by a written agreement executed by both parties.
