

## COMPETITION WITH CHANCE TERMS AND CONDITIONS

### 'Tik Tok Pink Wheel'

#### 1. THE PROMOTER

1.1. The Competition with chance is operated by **Bravonext SA t/a lastminute.com** ("Promoter") at Vicolo de'Calvi 2 - 6830 Chiasso (Switzerland).

#### 2. THE COMPETITION

- 2.1. [@lastminute\\_com](#) will go Live on TikTok and host a 50 minute long Live, the 'Tik Tok Pink Wheel'.
- 2.2. [@lastminute\\_com](#) will spin the Pink Wheel every time the account reaches 1000 likes or wins 100 followers.
- 2.3. We will spin one wheel to reveal which prize we will give away, and another wheel to reveal who is the winner.
- 2.4. The entrants fulfilling the requirements in section 5.1 will be eligible to participate in this Competition with chance ("**Competition with chance**").

#### 3. THE PRIZE

3.1. The prize consists of 12 voucher codes to book 12 Lastminute Holiday Deals. There will be 12 different winners. Each of the winners will receive 1 voucher to book a 2 nights package for one traveller, including flight & hotel, each for a different destination and value. (the "Prize").

##### Vouchers Terms and Conditions

- The winner can apply the voucher value to any booking they wish to make (not just to the destination in the prize) on our website <https://www.lastminute.com/promos/flash-sale.html> by inserting the voucher code in the designated field and pressing "Apply".
- The voucher will be valid until the end of the year.
- The corresponding discount will be deducted from the total amount paid to us only (excluding any payment made to the hotel directly).
- The winner may not exchange or redeem the voucher for cash.
- The winner can not use the voucher in conjunction with other vouchers or offers (i.e. cashback or gift card).
- lastminute.com reserves the right to modify, suspend or cancel the voucher at any time.
- lastminute.com reserves the right to cancel the required booking if the voucher is used in an improper manner.
- The code must be applied before completing the booking.

3.2. The Prize will be won by each of the winners on TikTok


3.3. The Prize excludes all additional costs not included in the Prize description, including but not limited to transportation to and from the airports and hotel.

3.4. The Prize is non-transferable, non-negotiable, and non-refundable, and no cash alternative will be offered.

3.5. In the event of unforeseen circumstances, the Promoter reserves the right to offer an alternative prize of equal value without notice.

#### 4. ENTRY REQUIREMENTS

4.1. The Competition with chance on Tik Tok runs from the x of x 2025 at x h am (GMT) (the “Opening Date”) to h (GMT) on the xx of xx 2025 between h and h (the “Closing Date”) (the “Competition with chance Period”). We will host this Competition every 2 weeks. Frequency could be increased depending on the level of participation. (the “Competition with chance Period”).

4.2. To enter the competition users shall post a comment with a pink heart  on our live session . Sending “gifts” in the chat will get users extra entries. Users will have up to 5 entries.

4.3. The end of the Competition with chance shall be determined by the end of the live session on Tik Tok We will continue to reveal the prizes on the wheel, every X likes or follows. When we reach minute 45 or we have revealed all 12 prizes, we will then count all the submissions from the chat. We will spin one wheel to reveal which prize we will give away, and another wheel to reveal who are the winners.

4.4. No entries received before the Opening Date or after Competition End will be accepted.

4.5. To enter the Competition with chance, Entrants must :

**4.6. By submitting a comment, the Entrants agree to:**

- Assign to the Promoter their intellectual property rights in the comment with full title guarantee and undertake to execute any documents and perform such acts as may be necessary to give full effect to this assignment.
- Waive all moral rights to the comment, including the story or tale accompanying it, under the Copyright, Designs and Patents Act 1988, as amended, and under all similar legislation in force globally, both now and in the future.
- Grant the Promoter a non-exclusive, worldwide, irrevocable licence, for the full duration of any intellectual property and moral rights in the comment, including any aspects of the story or tale accompanying it that cannot be assigned. This licence allows the Promoter to use, display, publish, transmit, copy, edit, alter, store, re-format, and sub-license the comment and any related materials for its intended purposes.

**4.7. The Entrant confirms and warrants that:**

- The comment is not defamatory and does not infringe upon third-party rights.
- The comment is not a product of artificial intelligence.
- There are no conflicting agreements that restrict the use of the comment.
- The Entrant has obtained consent from any individuals referenced or depicted in the comment, if applicable, for its use in connection with the competition, and such individuals have waived any rights they may have in relation to this use.
- If the comment references or includes information about a person under 18, the Entrant has obtained parental or guardian consent for its submission in connection with the competition.
- The Entrant shall provide evidence of any required consents at the Promoter’s request; failure to do so may result in disqualification from the Competition with chance.

4.8. By entering the Competition with chance, winners will be deemed to have accepted and agreed to be bound by these terms and conditions and our Privacy Policy available [here](#).

4.9. By entering the Competition, Entrants grant the Promoter a royalty-free, non-exclusive, perpetual and worldwide licence to publish his/her/their entry and any accompanying material in any and all

media, including but not limited to online, social media, television and print. In particular, by entering the Competition, the winner agrees to the Promoter publishing name and email address, and to participate in any reasonable publicity that the Promoter may require in connection with the Competition, including on [www.lastminute.com](http://www.lastminute.com), social media channels and on any kind of event made by the Promoter.

## **5. ELIGIBILITY REQUIREMENTS**

5.1. The Competition with chance is open to residents of the United Kingdom, Ireland, France, Italy and Germany aged 18 years and over.

5.2. For the avoidance of doubt, the Competition with chance is not open to

(a) employees of the Promoter or its holding or subsidiary companies;

(b) employees of agents or suppliers of the Promoter or its holding or subsidiary companies, who are professionally connected with the Competition with chance or its administration; or

(c) members of the immediate families or households of (a) and (b) above.

5.3. The winner must be eligible to claim the Prize that he/she/they may win.

5.4. The Promoter may require the Entrants to provide proof that they are eligible to enter the Competition with chance.

5.5. The Promoter will not accept entries that are automatically generated by computer, completed by third parties or in bulk, illegible or incomplete.

5.6. Entries on behalf of another person will not be accepted and joint submissions are not allowed. (by "person" the Promoter identifies an Instagram and/or TikTok account).

5.7. The Entrants shall indemnify the Promoter and keep the Promoter fully and effectively indemnified against all actions, costs, demands, losses, claims and expenses of whatsoever kind or nature arising from any actual or threatened breach or non-performance of any of the warranties, representations, undertakings or obligations on the Entrants' part contained in these terms and conditions.

5.8. If the Promoter suspects that the comment has been generated using artificial intelligence (e.g. bot, fake comments etc.), the Promoter reserves the right to disqualify the Entrant. This decision will be based on reasonable and technically feasible checks, provided these checks are neither excessively costly nor time-consuming for the Promoter, to verify the validity of the participation and/or the winning entry. The Promoter reserves all rights to disqualify the entrant if their conduct is contrary to the spirit or intention of the Competition with chance, or the winner fails to prove his/her/their eligibility, or disqualify ineligible entries, and to award the Prize to another winner should a winning winner be found to be ineligible.

## **6. AWARDING AND CLAIMING THE PRIZE**

### **6.1. winner Selection Criteria:**

- The twelve winners from TikTok will be selected amongst the users that commented on the live sessions referenced in Sections 2 and 4. The winners will be selected by chance, spinning the 'Pink wheel' by using an external, independent tool available at <https://spinthewheel.app>.
- The Promoter will store evidence of the tool's results as proof of fairness and transparency.

### **6.2. Notification of winners:**

- The four winners will be notified via private message on TikTok by the end of the competition.

### **Unclaimed Prizes:**

- If a winner fails to claim their prize within 48 hours of notification, the Promoter reserves the right to select an alternate winner.

- The alternate winner will be determined based on the same process, using the external tool <https://spinthewheel.app>.

6.3. Instructions on how to redeem the voucher will be provided to the winners via email or private message.

## **7. LIABILITY**

7.1. No responsibility can be accepted by the Promoter for any incomplete or illegible entries or any entries not received or corrupted during transmission, for whatever reason.

7.2. Promoter shall have no liability for system failures on any third party websites.

7.3. Promoter and its associated agencies and companies accept no liability for any loss, expense or damage which is suffered or sustained, whether arising from any winner's or Entrants' negligence, in connection with the Competition with chance and/or Prize.

## **9. FINAL PROVISION**
