Standard & Dimmable Drivers Ø120mm, Ø150mm, Ø180mm & Ø240mm

NOTE – To comply with regulations, installation must be carried out by suitably qualified competent person and in accordance with the current IEE Wiring Regulations (BS7671) and Building Regulations. A copy of the instructions must be left for the user/maintenance engineer for future reference.



ASSEMBLY AND INSTALLATION

- 1. Turn OFF power supply, ensure all required equipment and tools are present
- For installation in suspended ceilings, remove the relevant ceiling tile.
 Carefully mark the ceiling with the correct cut-out and check prior to cutting.
 NOTE The cut-out is smaller than the product size.
 The ceiling may require additional inner reinforcement, depending on construction and condition
- 3. Connect the LED driver to the mains supply. **NOTE** The driver is remote to the panel. Mains connection to the input terminals and the output terminal is to be connected to the lead supplied with the LuxPanel (Brown to +, Blue to -)
- 4. Connect the 2 parts of the lead from the LED driver to the LuxPanel
- **5.** The LED driver should be positioned on top of an adjacent ceiling section. It is not recommended to place the components on top of the panel due to the extra weight
- **6.** With the LuxPanel connected and installed, reinstate the mains power supply and test function
