




Office conceptual design for 2nd and 3rd floors

First Baptist church. The major portion of the ground floor and the entire second and third floors have been leased by J. Regentetic Company, prominent woman's wear concern, for its Peachtree street store, to be ready January s. The corner store was leased to Liggett's Drug Company, Prince & Smith are the architects.

First Baptist Church was demolished.




1929-30

Pringle & Smith and Peters Land Company announce & begin constructing Regenstein's Department Store.



1930

Regensteins opens in 1930 and hires the first women sales clerk in the City of Atlanta, Martha Owens.



1932

Regenstein occupies the upper 2 floors, while Bennett Jewelers and Liggett Drug Store occupies the street level retail.

Marx Realty acquires the Regenstein Department Store.
