

Historic Peter Paper Company Warehouse

Designed by Gove and Walsh architects, 1625 Wazee was built in 1899 with additional improvements in 1915. The first floor of the historic building boasts expansive storefront windows that were originally designed to showcase paper products in the showroom. The LoDo landmark served as a paper company warehouse until 1942 and has been listed on the National Register of Historic Places since 1988.


