### AH Root

- 2401 15th Street, Denver, CO 80202
- 48,072 SF
- Built 1892 | Renovated 2017

Standing tall as one of the last built cast iron structures in Denver, the AH Root Building has supported multiple industries since it's construction in 1884. From drug stores, warehouses and manufacturing, the cast iron and beam constructed walls have decades of stories to tell. Listed on the National Register of Historic Places in 1980, the AH Root building blends authentic features modernized for today's creatives.



### Big Chief Bottling

- 1537 Platte Street, Denver, CO 80202
- 13,540 SF
- Built 1890


The Big Chief Bottling Co. building was constructed in 1890 by John Huddart, a leading Denver architect known for designing public buildings and courthouses between 1882-1930. It served as one of Denver's first and largest bottling sites of the time. With Denver's budding craft beer scene, The Big Chief Bottling Co. building taps into the entrepreneurial spirit of those adventurers considering Denver for their next office space.



### Zang Building

- 1553 Platte Street, Denver, CO 80202
- 44,214 SF
- Built 1888 | Renovated 2017

Fermented in one of Denver's original brew houses, then known as The Rocky Mountain Brewery, The Zang Building served as the first commercial brewing enterprise in Colorado. The Zang building was one of the first establishments in the now young and lively neighborhood known as The Highlands. It's location is perfect for attracting companies interested in a work-live-play environment.
