

We are coming off another banner year for the tourism industry in Arkansas. Visitors enjoyed our state parks, marveled at our world-class museums, biked and hiked our trails, fished in our rivers and lakes, and experienced the diversity of our communities.

The industry's growth is measured by hospitality tax collections, tourism sector employment numbers and collections of the statewide 2% tourism tax. I'm happy to report increases in each area for the third consecutive year.

Continuing that trend in 2018 is certainly within our reach.

The trail system in Arkansas continues to grow for hikers and bikers. Arkansas has more than 300 miles of hiking trails through mountainous terrains and alongside rivers and streams. Some lead to the most beautiful waterfalls found anywhere in the world. Our mountain biking trail system continues to develop in the Ozark and Ouachita Mountains. Slaughter Pen in Bentonville and Iron Mountain in Arkadelphia, among others, opened new trails for experienced bikers in 2017.

I am most excited about the continued development of the Murphy Arts District (MAD) in El Dorado. The Playscape water park will open this spring and will attract families from all over southern Arkansas and northern Louisiana. Additionally, MAD Amphitheater and Griffin Music Hall will offer plenty of entertainment options. This project will soon enter Phase II of development and be a driving force for tourism in that part of the state.

All 75 counties have something to offer. These are just a few examples of the great things happening for tourism in Arkansas, and what keeps people coming back year after year.

Dear Tourism Industry Friends,

"Embrace change" has been the unofficial motto of late in the Arkansas Department of Parks and Tourism. With change comes opportunity, and we are excited about what the future holds for our industry.

Arkansas's historical War Memorial Stadium became part of our department's responsibility in 2017. Since then we've hosted a major stadium concert with Guns N' Roses attracting almost 24,000 fans, completed a football season full of high school and college games, and secured the 2018 Arkansas Razorbacks Red-White Spring Game. And the "Grand Ol' Lady" isn't done yet - I firmly believe that some of her best days still lie ahead.

The Arkansas Parks and Recreation Foundation was created by commission member John Gill in 2017. It's a nonprofit organization that will allow for private funds to be raised and channeled into our parks system and recreation facilities across The Natural State. We thank John for his tireless work and progressive vision.

Another significant change was the retirement of our friend Joe David Rice. He devoted more than 30 years of his life to our industry as the director of tourism. While we miss Joe David's presence, we are fortunate that Jim Dailey has stepped into that role and has continued to push our tourism efforts forward.

We, as a state, enjoy a great deal of momentum in attracting tourists. Early numbers suggest that 2017 collections of the 2% tourism tax will have increased by 3.23% over 2016. We also experienced job growth in the tourism sector in 2017.

So much of this is possible because of our public-private partnerships. The private sector is building new hotels and restaurants. Communities are investing in developing world-class museums, entertainment venues and trail systems. And the state is diligently working to improve our 52 state parks.

These amenities, coupled with outstanding customer service, are what keep tourists returning to Arkansas year after year.

Thanks for all that you do to help our beloved state thrive as a tourism destination.




