



## **MODERE LIVE CLEAN PLEDGE - SMARTSHIP PROGRAMME**

### **TERMS AND CONDITIONS**

1. Organiser of the Live Clean Pledge SmartShip Programme (the "Promotion"): Modere Europe BVBA, Telecomlaan 9 (B5), 1831 Diegem, Belgium (the "Organiser").
2. The Promotion period starts at 00.01 on 8<sup>th</sup> November 2018 and ends at 11.59 p.m. CET on 18<sup>th</sup> October 2019.
3. Eligibility: All Modere account holders (the "Modere members") shipping one of the Live Clean Pledge Selections to one of the destinations served by Modere are eligible unless it is stated otherwise.  
Eligibility also requires adherence to these terms and conditions.  
  
If at any point during the Promotion Period a Modere Social Marketer or Customer ("Member") account is suspended then their activities related to the Promotion during the suspension period may not count toward the promotion.
4. This promotion is specifically and uniquely available when a Live Clean Pledge Product Selection (the "Selection") is included on a SmartShip template.
5. The Selections are those featured in the dedicated Live Clean Product Selection of the Modere European website [www.modere.eu](http://www.modere.eu)
6. Incremental savings of up to 15% can be accrued when a single Selection is purchased for consecutive months via the SmartShip programme. The savings are awarded on a monthly basis in increments of 5% per month starting at 5% discount in the first month ("Month 1") that the Selection is processed up to a maximum of 15% in the third consecutive month ("Month 3") and any consecutive month thereafter. Eg:
  - Month 1 - A single Selection successfully processed via SmartShip will generate a discount of 5% on both the selection selling price and Customer/Social Marketer points.
  - Month 2 - The same Selection as in Month 1 successfully processed via SmartShip will generate a discount of 10% on both the selection selling price and Customer/Social Marketer points.
  - Month 3 - The same selection as in Month 1 and Month 2, successfully processed via SmartShip will generate a discount of 15% on both the selection selling price and Customer/Social Marketer points.
  - Month 4 - The same selection as in Month 1, 2 and 3, successfully processed via SmartShip will generate a discount of 15% on both the selection selling price and Customer/Social Marketer points.
7. Discounts will be applied to the selling price and Customer/Social Marketer Points.
8. Discounted price information will appear in the SmartShip processing confirmation email.
9. The discount will be awarded to a maximum of one of the same Selection per SmartShip template. Multiples of the same Selection in a SmartShip template will not be awarded the discount Promotion.
10. If a selection is removed from a SmartShip template by the Member (whether intentionally or accidentally) and added again at a later date then, then the discount cycle highlighted in (5.) will recommence with a discount of 5% on selling price and Customer/Social Marketer points when the next SmartShip template is processed.
11. Modere's usual return policies apply.
12. The Promotion is subject to availability.
13. The Promotion may be subject to change without notice and may be withdrawn at any time.
14. The Terms and Conditions relating to the Promotion are in addition to, and do not permanently supersede or modify in any way the Modere General [Terms and Conditions](#).
15. All decisions relating to the promotion are at the sole discretion of the Organiser and are final.
