- You qualified as Elite at least 6 times in 2018.

- 2. The Modere Leadership FLY-IN business promotion (the "promotion", "Leadership FLY-IN") is open to all Social Marketers based in one of the European countries supported by Modere Europe.
- 3. Modere will disqualify volume generated by duplicate accounts.
- 4. In the event that purchases which contributed to a qualification are returned within the 30-day return period, the qualification may be retracted.
- 5. Qualifiers and their guests are required to make their own travel arrangements to and from the airport in their country of residence. Qualifiers should ensure that they are in possession of the proper travel documentation (valid passport, visa, ESTA) prior to booking any travel arrangements. The same applies to their guests.
- 6. Modere Leadership FLY-IN accommodation includes lodging for three nights, meals and accompanying drinks, transfers to and from the airport to the destination hotel and selected activities for up to two people depending on the qualification achieved. The first of the three nights is the night following the first day of the Leadership FLY-IN and the third night is the night prior to the last day of the Leadership FLY-IN.
- 7. The organiser will pay an account that qualified for air fare a lump sum of 1,000.00/£800.00 per ticket, provided the qualifying account attended the Leadership FLY-IN

- 10. Qualifiers will be contacted by the organiser's staff to discuss the reward details and be advised of the process.
