SHARE QUALIFICATION EXAMPLES

1. In April I qualify at Gold sales title, my Customer Pod amounts to 2600 CP and I generate 60% sales volume (1560 CP) from Sport, Trim, Ignite, Activate & Body Transformation System purchases.

As a consequence I am eligible to **earn 2 shares** in the April Body Transformation Bonus Pool.

2. In April I qualify at Platinum 1, my Customer Pod generates 40% sales volume from Sport, Trim, Ignite, Activate & Body Transformation System purchases.

As a consequence **I am not eligible to earn shares** in the May Body Transformation Bonus Pool as my Customer Pod did not generate the minimum 57% sales volume from Sport, Trim, Ignite, Activate & Body Transformation System purchases.

REQUIREMENTS TO PARTICIPATE IN THE POOL

To earn shares, an individual must be a qualified Social Marketer in the given month and must have achieved at a minimum the Bronze sales title with Customer Pod volume generating a minimum of 57% sales through Sport, Trim, Ignite, Activate and Body Transformation System. The **BODY TRANSFORMATION BONUS POOL** which runs from the 1st March until 30th June 2019 will be paid according to the following rules & requirements.

RULES OF ENGAGEMENT

1. Share value will be determined by dividing the total value of the BODY TRANSFORMATION BONUS POOL fund by the number of shares allocated in the given month.
