

MODERE GLOBAL ACHIEVERS

Between 1 March and 30 June 2020 new Social Marketers have the opportunity to generate additional earnings ranging from **140€ / £125 and up to 300€ / £270** when they achieve **1500 points or 3000 points** in their first complete month at Modere.

For new Social Marketers joining as of June 1st 2020, the Modere **GLOBAL ACHIEVERS** promotion period will conclude at the end of **their first complete month July 31st 2020**. Existing Social Marketers are not eligible to participate in the **GLOBAL ACHIEVERS** promotion.

To earn a **GLOBAL ACHIEVERS** Bonus payment new Social Marketers must in their first complete month:

1. **Achieve minimum 1500 points** in their first complete month with Modere to earn the **140€ / £125 bonus**.
or
2. **Achieve minimum 3000 points** in their first complete month with Modere to earn the **300€ / £270 bonus**.

The 1500 or 3000 points must be generated by the following:

I **earn a GLOBAL ACHIEVERS Bonus of 300€ / £270 with my April volume month commission**.
3. I enrol as a Modere Social Marketer on May 4th 2020, I achieve 3000 points in June volume month generated from my own Marketer Points (MP), my Customer Points (CP) and Marketer Points of new Social Marketers I enrolled in June volume month. I **earn a GLOBAL ACHIEVERS Bonus of 300€ / £270 with my June volume month commission**.

I enrol as a Modere Social Marketer on March 18th 2020, I achieve 1000 points in March volume generated from my own Marketer Points (MP), my Customer Points (CP) and the Marketer Points (MP) of new Social Marketers I enrolled in March volume month **and** I I achieve 2000 points in April volume generated from my own Marketer Points (MP), my Customer Points (CP) and the Marketer Points (MP) of new Social Marketers I enrolled in April volume month. **I earn a GLOBAL ACHIEVERS Bonus of 300€ / £270 with my April volume month commission.**
5. I enrol as a Modere Social Marketer on May 10th 2020, I achieve 1500 points in May volume generated from my own Marketer Points (MP), my Customer Points (CP) and the Marketer Points (MP) of new Social Marketers I enrolled in May volume month **and** I I achieve 1000 points in June volume generated from my own Marketer Points (MP), my Customer Points (CP) and the Marketer Points (MP) new Social Marketers I enrolled in June volume month. **I earn a GLOBAL ACHIEVERS Bonus of 140€ / £125 with my June volume month commission.**
