Payment and membership term

* Payment for Business Collective membership is due 14 days after the receipt of invoice, upon which the membership term will commence on the first day of the following month, valid for twelve (12) months.

Tickets & Hospitality

* Up to four (4) tickets can be used per performance. Additional tickets can be assessed upon request and subject to availability.

* Tickets provided by MTC are subject to the Live Performance Australia (LPA) Ticketing Code of Practice and to MTC Ticketing Terms and Conditions of sale. All guests attending must abide by these terms and conditions. The code of practice is a voluntary industry code setting out industry best practice standards of consumer protection for the ticketing of live entertainment events in Australia. Information on the code is available freely online or can be provided by MTC on request. MTC reserves the right to vary ticket prices, and/or vary advertised programmes, seating arrangements and audience capacity.

* Unused tickets are considered to be forfeited and are not redeemable as credit at the end of the membership term.
