

**Metal Detection:** Packaged products are run through metal detectors as part of packaging process. Challenge sizes are 2.0mm ferrous, 2.5mm non-ferrous, 3.5mm 316 Stainless steel. Some packing lines use x-ray for metal detection with a limit of 1.5mm 316 stainless steel.
