Use only as directed on the labels

Each of qemp's hemp-derived CBD products contain a full profile of cannabinoids from hemp. This innovative approach to providing the body with all the benefits of a full spectrum of cannabinoids is what makes qemp "next level." While many will benefit from qemp products, please be aware of the following:

Making any improper, false, or misleading claims verbally or in writing including on any website, written communications, testimonials, or social media platforms can result in a qemp Compliance investigation or FDA/FTC investigation.

Do not make any claims on social media

Social media is a powerful tool for our Distributors. As such, qemp and regulatory bodies like the FDA and FTC monitor Distributors' social media platforms closely for improper, false, or misleading claims.

Never make any improper, false, or misleading claims verbally or in writing, including on any website, written communications, testimonials, or social media platforms.
