HOW ARE BOOTH LOCATION ASSIGNMENTS DETERMINED?

NCAI's policy is to place exhibitors in a first come, first served basis for those who have submitted a registration form and completed their booth payment. All booth assignments are final.



Three to five weeks prior to the event, the marketplace decorator will email all exhibitors who have submitted a complete application and full payment a package containing full details on the exhibit space.



IS THE MARKETPLACE OPEN TO THE PUBLIC?

NCAI's marketplace is open to the public for the entire event. Feel free to invite your family, friends, colleagues, and networks to attend.



CAN EXHIBITORS ATTEND OTHER PARTS OF THE CONFERENCE?

Exhibitor registration does not include conference registration. Exhibitors must separately register as conference attendees to attend all breakout sessions and general assemblies. There are conference events that are open to everyone, including federal consultations, federal listening sessions, a welcome reception, and cultural night.
