 Listening Session to Inform Federal Agencies' Environmental Justice Strategic Plans Federal agencies are eager to engage Tribal leaders in the development of their Environmental Justice Strategic Plans pursuant to Executive Order 14096, Revitalizing Our Nation's Commitment to Environmental Justice for All, which advances the Federal government's efforts to deliver real, measurable progress on environmental justice. The White House Council on Environmental Quality (CEQ) will also share how Executive Order 14096, signed by President Biden on April 21, 2023, recognizes that addressing Tribal concerns and respecting Tribal values, including the need to protect sacred sites and Tribal sovereignty, are critical to advancing environmental justice. Engagement with Tribes based on their expertise and unique interests is essential so that agency Environmental Justice Strategic Plans reflect Tribal priorities and recognize, honor, and advance Tribal sovereignty and Tribal cultural practices—including subsistence practices, ways of living, Indigenous Knowledge, data collection, research, and traditions. In this session, Federal agencies will seek to learn how their Environmental Justice Strategic Plans can most effectively reflect and support Tribal priorities. In addition, feedback will also be welcome on how the National Science and Technology Council's Environmental Justice Subcommittee can address relevant gaps in science, data, and research through its all-of-government research plan. Tribes will be given the option to submit additional feedback in writing after the session.
