For the purposes of the Sweepstakes and these Official Rules, "Sponsor" shall include Sponsor's affiliates and related companies, including without limitation, its parent, sister, affiliate, and subsidiary companies, retailers, franchisees, advertising, promotion and fulfillment agencies, suppliers of material and services related to the Sweepstakes, and any other corporation, partnership, sole proprietorship or other legal entity directly involved in the Sweepstakes and each of their respective owners, members, officers, directors, employees, agents, and other authorized representatives.

1. SWEEPSTAKES PERIOD. The "<u>Sweepstakes Period</u>" starts on Saturday, July 28, 2018 at 9:00 a.m. PDT and ends on Thursday, August 23rd, 2018 at 11:45 a.m. PDT (the "<u>Entry</u> <u>Deadline</u>").

2. ELIGIBILITY. The approximate retail value of the Grand Prize as of the date of publication of these Official Rules is 2,170.00 ("<u>ARV</u>"). The ARV may be subject to change. Any difference between the ARV and the actual value will not be paid to the Grand Prize Winner (as defined below in <u>Section</u> <u>5</u>).

**4. HOW TO ENTER**. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. There are two (2) ways to enter the Sweepstakes:

By submitting an entry, Entrant confirms that he/she has read, understands and agrees to abide by these Official Rules. Each entry must adhere to the Eligibility Criteria listed above or such entry will be void and ineligible for entry into the Sweepstakes. All entries must be received by the Entry Deadline. Limit one (1) entry per person only. Entries must be made using only an email address subscribed to and registered in the Entrant's name. Entries must be submitted by the Entrant him/herself. In the event of a dispute regarding entries submitted by multiple individuals using the same e-mail account, the only eligible entry will be the entry submitted by the authorized subscriber to the e-mail account used to enter the Sweepstakes at the actual time of entry.
