DES Report- Wade Pelham and Jim Talvy

- Education outreach last week during 2-day GSOWA conference in Manchester
- Wild NH Day 4/19/25 to include clean water act outreach, GetPumped NH
- Had a meeting with engineering firm regarding grease disposal what makes for a successful grease receiving program for other plants to be adaptable to that; such as can we do this and make money on this. This was the first meeting.
- Portsmouth is looking at funding options to enhance septage receiving at Pease. It is mostly commercial industrial now. There are challenges with the amount of storage they have so cannot take an infinite amount. There is also a highway nearby for easy access to facility. The SAG Plus Program offers 10 percent grants for projects expending septage receiving in NH and an extra 2% for the towns; funding has to be reauthorized by legislation every year.

DES- Jim Talvy

- Busy with renewals: new trucks and reporting 99.5% compliant
- 745 trucks now permitted for NH and over 200 companies; added a new one today by Keene
- Discussion on how to notify these new companies about NHASH- give newsletter and/or or business cards to direct to NHASH website and contact information

Water Counsil Report- Larry Maznek

- Went over 1000 rules for DES. They are going to try to put through all risers to grade for every chamber on the tank. This will be on new construction or new systems/ upgrades going forward.
- LiDAR ?JLCAR will be permitted for surveying by satellite; cut off dates as back as 1967 for accepting on how many rooms in a domicile now up to 1987; going to 2 compartment tanks instead of single (i.e. 2/3 in the first tank and at least 1/3 in the second chamber for 2 compartment tanks); to replace a D box in the field if in a butterfly system cannot be replaced

without notifying DES. If it is a single D box outside the field or front of the field then you can replace in kind, whether it's on any type of system.

- July, June, Sept appeal hearings in front of water council board usually get settled before going to hearing
