The following parents have been invited, via a telephonic call, to the meeting on 17th Dec at 8.30 AM











INSTRUCTIONS

- Fees once paid are non-refundable.
- The Tuition Fees will be collected quarterly and before the 5th of every quarter 5th June, 5th Sept., 5th Dec. and 5th March.
- Transportation fees are to be paid before the 5th of every six months i.e. June - Nov and Dec to May.
- Tuition fees, Bus fees & Van fees have to be paid for the entire academic year (12 months)
- Late fine of Rs. 100 per day.
- A fine of Rs. 500 will be levied on every return cheque.
- Parents should give separate cheques for each child in case of more than one child studying in the school.
- Post-dated cheques will not be accepted.
- Non-payment of fees will result in :
 1. Cancellation of admission. 2. Debarring of a student from appearing for all ensuring exams.
