1. General / legislation

It is hereby confirmed that the delivered item(s) / food commodity items made from plastic for use as food packaging / is/are suitable for coming into contact with food. The item(s) comply with the requirements set out within the following legislation (in each case the issue of this declaration, including any amendments shall be valid at this given time):

- Regulation (EU) No. 1935/2004 for materials and objects (including active and intelligent food contact material(s) and items), which are designed to come into contact with food comply with directives 80/590/EEC and 89/109/EEC – in their current valid version(s).
- Regulation (EU) No. 2016/1416 dd. 14.09.2016, (EU) No. 2017/752 dd. 28.04.2017 and (EU) No. 2018/831 for materials and objects made from plastic, which are designed to come into contact with food in their current valid version(s).
- No substances acc. Annex § 6 of the EU 10/2011 are used
- Knives are intended for cutting food of all kinds
- Knife handles are made of TPE / TPS or PP
- Blades are made of chrome molybdenum steel 1.4110 / 1.4116 / 1.4034

Any amendments to the compositions may be made only following consultation, and by obtaining written consent, which will require an updated Declaration of Conformity to be issued.

Any new releases must comply explicitly with the relevant legislation: any substantial changes in legislation, and changes to regulations must provide important information which is relevant both to the product, and to its usage.

2. Migration and residual contents

Limits must be consistently observed. Migration and residual contents will be reviewed on a regular basis. The measurements must comply with Directive 82/711/EEC – Basic rules for migration testing (including the modification Directives 93/8/EU and 97/48/EU) must also comply with Directive 85/572/EEC – Food simulants for migration testing (including the modification Directive 2007/19/EU). Rules for migration testing are also specified in regulation No. (EU) Nr. 2016/1416 and EU Nr. 2017/752 dd. 28.04.2017.

2.1 Method

Determination of total migration in 95% ethanol as a replacement test for the determination of total migration in olive oil.

The repeated contact for reusable articles in accordance with Annex V, Chapter 3.3 of the European Plastics Regulation (EU) No 10/2011 is checked. The test is run with the same sample three times, each time using a new simulant. The match with the overall migration value is judged on the basis of the migration value found in the third test.

Test method: Euro

European standard EN 1186-14

Simulant solvent:

95% ethanol

Contact time and temperature: 2 hours / 70 ° C

Examination 1st and 3rd contact

Test conditions:

Immersing

Contact area/volume:

1 handle / 300 ml
