Welcome

President Rick Reichert welcomed the membership and thanked them for attending the NYS GIS Association Annual Meeting. President Reichert acknowledged and thanked Board Members, Committee Chairs, and Committee Members for their dedication and hard work. President Reichert also thanked the NYGeoCon Committee for an excellent conference.

Treasurer's Report: Christa Hay, Treasurer

The Treasurer's Report dated September 24, 2019 was reviewed. The current balance is \$71,893.50, which does not reflect final payments for NYGeoCon. The balance generally averages around \$45,000.00, with approximately \$8,000.00 in yearly operating expenses, not including the annual event which can range from \$15,000.00 for the GeoSpatial Summit to \$95,000.00 for NYGeoCon. Major expenses for the year include website hosting and domains, D&O insurance, marketing and awards, regional conference sponsorships, and webinar and meeting expenses. To date there has been \$5,521.05 in income from membership dues, and \$5,136.10 in expenses. Estimated upcoming yearly operating expenses are approximately \$7,750.00, not including expenses for NYGeoCon or the GeoSpatial Summit.

A motion was made by Carol Zollweg to approve the Treasurer's Report. Motion was seconded by Karyn Tareen. Motion carried unanimously.
