

NYS GIS Association Annual Meeting Minutes Virtual Annual Meeting Wednesday, October 21, 2020 Minutes by Michelle Debyah

Members Present: 52 members in attendance of 414 members in good standing, quorum established.

Minutes: The meeting began at 4:03 PM.

Welcome

President Jonathan Garner welcomed the membership and thanked them for attending the virtual NYS GIS Association Annual Meeting. President Garner expressed the importance of meeting, even if virtually, to provide updates on the Association, hear from speakers on the response to COVID-19, and recognize award winners in the fight against COVID-19.

President Garner recognized the current Board of Directors and thanked everyone on the Board for their efforts. The ballot for this year's election will be distributed to the membership in the near future, and the results will be shared in about a month.

Treasurer's Report

The Treasurer's Report dated October 20, 2020 was reviewed. The current balance is \$54,242.83. The balance generally averages around \$50,000.00, with about \$8,000.00 in yearly operating expenses. This year saw less in operating expenses due to many events being canceled that the Association traditionally sponsors. Those expenses do not include the annual event which can range from \$15,000.00 for the GeoSpatial Summit, to \$95,000.00 for NYGeoCon. Major expenses for the year include website hosting and domains, D&O insurance, marketing and awards, and webinar and meeting expenses. To date there has been \$4,650.14 in income from membership dues, and \$5,912.98 in expenses. Estimated upcoming yearly operating expenses are approximately \$7,693.00, not including expenses for NYGeoCon or the GeoSpatial Summit.

A motion was made by Rick Reichert to approve the Treasurer's Report. Motion was seconded by Chris Badurek. Motion carried unanimously.

GIS, COVID-19, and Government Speaker Series

- Mike Ross, City of Rochester
 - Grab and Go Meal Finder
 - City of Rochester and Rochester City School District served children prepackaged meals during COVID-19
 - Application helped City residents find the closest distribution site
 - City staff to analyzed concentrations of children and walk shed analysis to open additional, better distributed meal sites
 - Application uses ArcGIS Online Nearby template and works well on mobile
 - Shop the ROC Business Finder
 - Directs people to businesses that are open for business
 - Can filter by category
 - Mobile version shows businesses closest to users location
 - Monroe County's dashboard gets information directly from Monroe County Department of Health Department
- Rick Reichert, Oneida County
 - Oneida County had an Enterprise structure set up and some familiarity building web maps, but minimal experience developing dashboards at the beginning of the pandemic
 - Through tutorial studying and assistance from others in the industry, they worked with the Health Department and utilized State data to develop a publically available dashboard
 - The process was refined over time to include comparative analysis based on population numbers and impacts on County ARC community to identify areas in need of extra assistance
 - Implemented proactive risk analysis based on census and block group information to identify areas of increased risk for infections using an in-house designed risk matrix that included elderly populations, poverty, health risks such as hypertension, population density, average travel mileage, etc. to preform weighted risk analysis
 - Also created a dashboard for the six-county Mohawk Valley Region using State data
 - Dashboards have led to enhanced awareness of capabilities in the County so they are getting a lot more requests for similar work
- Frank Winters, GIO, New York State
 - The Association has been a wonderful asset for collaboration
 - GIS is front page news people are doing fantastic work, but limited by availability of data and impact
 - Working with regional groups Frank found people wanted to have more impact
 - COVID is best understood in the context of space and time
 - A cholera outbreak in London in 1854 was solved when Dr. John Snow's map of cholera cases led to the removal of a handle from a pump

- o Data accuracy, precision, and resolution can change the view
- Temporal resolution is the ability to get smaller and smaller slice in time
 - Daily testing in sewage treatment plants
 - Move upstream to understand smaller sewer sheds by opening manholes
- If data is too granular anomalies get smoothed out
 - For example, an area with high infection rates also has low census return rates
 - Hypothesis could be perhaps a lower level of engagement with government
- National Pandemic GIS Task Force URISA, NSGIC, and NAPSG Foundation collaborating on a national GIS playbook
- Health Spatial Data Infrastructure OGC worldwide spatial data infrastructure (SDI) focused on a health spatial data infrastructure
- Frank is gratified to see the Governor talking about mapping

 - Feedback has been very positive.
- Will there be a GIS strategy for vaccine distribution?
 - Esri has tools that are optimized for vaccine distribution. Conversations are starting with the Department of Health to distribute a vaccine.
- Was there press for the City of Rochester Grab and Go site?
 - Yes, Communications Department put it front and center on the City website and it was picked up by local news. It hasn't received as much publicity lately because most residents now know where to go.
- Is there a platform or ideas for a chance to network or connect with fellow people in the field?
 - Not at the moment, perhaps something we can work on in future to help people collaborate virtually.

President Garner thanked the presenters and attendees, with a special thank you to Melissa Hegeman for running the meeting. He also thanked the Board of Directors, especially Karyn, Mary Susan, and Michelle for assembling the virtual event agenda.
