#### **Appendix 1**

#### Amy's RC Diary 1989 - 2020

Oh yeah, was the answer to a question an 8 ½ year old Amy was asked by her father Dave while watching RC car racing at Hamilton clubs Bristol Park off road track in late 1988. After seeing her excitement, the question was if we sell the go kart would you like to have a go at racing RC cars. Kart sold and it was off to Kits N Bits model shop where they met Bev and Rob Simpson who told them about the indoor racing at table tennis centre on Saturday nights. The indoors choice was made, and a Monster Beetle was purchased July 1989.

Once assembled a lot of backyard practise was done and off to her to her very first race meeting on 2 September 1989. Dave recalls a time pre RC at Frankton Primary School on a show and tell day in her class when Amy came home very down having not been able to contribute much due to her physical limitations. Mum and Dad could feel her pain and disappointment. When the next one came around however it changed Amy's outlook on life forever. This time armed with her Monster Beetle out on the school netball court Amy instantly became the most popular kid in class, at least with the boys anyway. A massive confidence boost for her that has carried her thorough to this day.

In 1990 saw the real start of the very successful indoor Drivers' Series. As well as race Amy offered to help Bev on the race computer having attended computing classes at CCS. At the age of 12 Amy took over the computer from Bev, as well as race. Amy began helping the then President and Drivers Series Co-ordinator Doug Holmes with all the paperwork for the series including entry forms, race books, designed the posters and all the race day computer work involved in the series. Friday night set ups, early Saturday mornings, late evenings and prize-giving's. Amy loved that she could contribute so much to her chosen sport. 1994 saw touring cars enter the scene and Amy and Dave realised a need for a proper racetrack. Materials available and Dave's skills on a plastics fabricator saw Amy and Dave start a 4-month build, late nights, weekends, Amy on a paint brush – "legend". The new track ready for the first round of Drivers Series June 2994.

1996 saw a move to Claudelands Showgrounds. Amy continued with her heavy workload at race control for race nights points rounds and Drivers Series duties as well as running her Stock Truck finally putting in 2010 putting No 1 on the door.

Fast forward 2013 Amy took her first break from the computer in 20 years to recharge her batteries and not long after her racetrack went into storage. In 2015 Amy took a trip to Tauranga RC club new indoor venue at a Greerton hall with her truck to have a go on carpet. Soon however offering to run their race computer for them – surprise, surprise. Gave Dad a call to go over and see the great job the guys had done making a track out of bits and pieces. They both said we can help with that. Christmas break saw father and daughter together again on track duties. This time Dave scrubbing brush and Amy on paint brush – legends. Refreshed track delivered for the start of the 2016 season.

2017 saw a move to a bigger hall at the Mount. Amy now running the meetings from race control and a committee member. Still racing in Hamilton but not enjoying their new venue with her ground zero drivers view making it very difficult to gauge most parts of the track.

2020 saw Amy move her racing here to Tauranga where she can now see all of the racetrack, she is very proud to have helped build with Dad 26 years ago and loving it all.

Amy became a committee member, club captain and has now taken over the President and Secretary roles as well.

Amy has never missed a year's racing in 30 years. "I'm having lots of fun doing it" she says. "The respect that is shown for Amy and her commitment to RC racing in a male dominated sport is awesome" says a very proud Mum and Dad. Wow, all this from a primary school "show and tell", Dave says.

## est mini grand prix track in North Island

With the recent comple-tion of the Taranaki Radio Controlled Car Club's new racing circuit at Centennial Drive, New Plymouth has become the North island centre of this exciting sport.

The circuit has been con-

The circuit has been constructed on the old car park that served the accommodation site during the power station construction, and is the first such permanent facility in the North Island.

The circuit will have its competitive "christening" this weekend when more than 30 of the top cars in the North Island converge on New Plymouth for the first ever Island championship—the Quinn's Radio North Island Championships. The track was used yesterday for practice runs and the first heats.

Racing resumes this morning at 9 a.m., with further heats being run until about 11 a.m. Then the finals will be run off.

The host club, which has raced until now on temporary circuits at such places as Highlands School

and the Ngamotu Tavern carpark, expects to do par-ticularly well at this in-augural championship

Club members recently visited Auckland to take part in the first round of the Champion Driver series; the five cars that were entered all finished in the top 12. The successful drivers on that occasion were P. Dalton (2nd), G. Henry (4th), G. Day (9th), B. Talbot (10th) and G. Duthie (12th). Dey's 9th placing was the achievement of the meeting as he had only been in the sport for four months.

These drivers will all be competing here this weekend, as will such other big names in the sport as R. Hoare (Wellington), the top North Island driver last year, J. Hall (Wellington), K. Taylor (Palmerston North) and T. Webster (Auckland). Incidentally Dalton and Henry finished 2nd and 4th respectively in the North Island drivers' ratings last year, with Taylor finishing 3rd.

The new track was sited not only with the needs of the racers in mind, but also looked to the comfort of spectators who have been attracted to race meetings in the past in tremendous numbers. Matchless views of the action will be obtained from a 2.4m bank above the track. The track was laid by Stan Riddick over a period of two months, most of that time being spent in rolling to achieve the



# In a class of their own . . .

These cars may not be Formula One Grand Prix vehicles — but at least their operators can pretend.

The Taranaki Radio Control Car Club meets in New Plymouth on the first Sunday of each month for race meetings and on the third Sunday for a practice day.

Two classes of car are used by members of the club, which this year totals 16 people. One is the one-eighth scale gas car and the other is a one-twelth scale electric car.

The difference between the two is that the gas car has a model aircraft engine, creates more noise and has a longer running capacity — making pit stops when it needs to refuel.

The electric car is not as big or fast and has a rechargeable battery which runs for eight minutes.

You could also expect to pay twice as much for a gas car. Current prices have them selling at \$1000, said club secretary Graeme Henry, New Plymouth.

The race meetings are run on a handicap-type system, with six cars running at a time, he said. The results are added up at the end of the day, with the fastest not necessarily coming out on top. Points are totalled, going towards a trophy presented at the end of the year.

Major events on the club's calendar are the New Zealand championships at Easter and the Taranaki championships in February.
