## **OFFICIAL MEMO (22<sup>nd</sup> January 2021)**

### **21.5T Spec Touring Motor**

Following the 2020 NZRCA AGM and subsequent online voting, remit #31 from Hawkes Bay in relation to 21.5 Spec motor for EP On-Road was passed and the NZRCA executive were charged with tendering the supply of motors.

**Proposed Rule: A7.1**

**A7.1a** Drivers can only use the specified 21.5 Brushless motor as selected by the NZRCA for that year.

**A7.1b** The specified motor, to be chosen by NZRCA executive will be updated in a regular two yearly cycle using a tender process.

**A7.1c** The motor selected will be specified for a two 'calendar' year window .

Tender invitations were put out in November 2020 and closed on 10<sup>th</sup> December.

Based on the tenders received, the NZRCA executive have selected the R1 Wurks V16 BRCA Version (No Epoxy) – supplied Etched with NZRCA Logo as the spec motor. The tendered price for this motor is \$150.00 (*subject to review by NZRCA as required*) and will be available via Hubersport. <http://www.Hubersport.co.nz/>

Please be advised that the NZRCA executive unanimously voted that the control motor period would be as follows:

**(Rule as voted in A7.1c** The motor selected will be specified for a two 'calendar' year window.

*The third year would act as a \*crossover, when the newly specified motor would take effect, but the current motor could still be used.*

**2021 = crossover year:** 2020 rule being: ROAR/EFRA approved motors or R1 Wurks V16 BRCA Version can be used

**2022 – 2023:** Only R1 Wurks V16 BRCA Version (NZRCA Etched) can be used

**Late 2023:** Motors to be re-tendered

**2024 = crossover year:** R1 Wurks V16 BRCA Version or new NZRCA approved tendered motor can be used

Hubersport are in the process of importing stock from suppliers and will advise the NZRCA member purchasing process in due course. As this information comes to hand, we will post this on the NZRCA Facebook page and Website.
