

OBOS TAKSONOMI-RAPPORTERING 2024

Innledning

Formålet med EUs taksonomi er å drive frem bærekraftige investeringer ved å klassifisere hvilke aktiviteter som kan betegnes som bærekraftige. For at en aktivitet skal være bærekraftig i henhold til taksonomien (aligned), må den bidra vesentlig til minst ett av EUs seks miljømål og ikke utgjøre vesentlig skade for noen av de øvrige (DNSH). Aktiviteten må også oppfylle mimimumskrav til sosiale og styringsmessige forhold.

Som en del av EU Taksonomiens offisielle rapportering skal OBOS rapportere på KPIene gitt i EU kommisjonens regulering 2023/2486.

For OBOS-konsernet gjelder følgende KPIer:

- Omsetning (Turnover)
- Driftskostnader (OpEx)
- Investeringskostnader (CapEx)
