Lumo and Oneplanetcrowd enable cross-border crowdfunding for solar energy

Amsterdam - 5 April 2017 – Today the two crowdfunding platforms Lumo (France) and Oneplanetcrowd (The Netherlands) started a joint campaign to raise capital for the solar park Torreilles, located close to the city of Perpignan in the South West of France. The two platforms jointly developed a solution to overcome the barrier of cross-border crowdlending in Europe and made it possible for French and Dutch citizens to participate in a European project to contribute the energy transition.

The future of clean energy is all about access to finance. There is still a huge gap between demand and supply of finance for energy transitions. To achieve real growth, a stronger involvement of citizens from all over Europe is essential. At the same time the growth of crowdfunding as an alternative means of financing is continuing. However, for a platform it is difficult to promote its projects in other EU countries, because in each specific EU country a different permit or license from the financial regulator is required. Harmonisation of regulation in the EU would make it easier for citizens to invest across borders, but this process will still take a lot of time.

The two crowdfunding platforms Oneplanetcrowd and Lumo jointly developed a solution to make it possible to conduct a crowdfunding campaign on a platform in another EU country. The two platforms are members of CrowdfundRES. This EU funded project aims to unleash the potential of crowdfunding for financing renewable energy projects in Europe.

Oliver Gadja from European Crowdfunding Network (ECN): "Offering cross-border investments in order to allow access to renewable energy projects is an important goal in the EU, but is difficult due to the various jurisdictions. I am excited that two members of ECN together found a practical solution for crossborder crowdlending in Europe."

The project selected for this pilot experiment is <u>solar park Torreilles</u>, close to Perpignan and near the highway that is often called the 'Route du Soleil'. This project is also funded by the investors of Lumo's crowdfunding platform. The project developer, Amarenco, has set up a special entity that allows for crowdfunding from the Netherlands. After the funding is raised successfully, the entity will buy bonds from the Torreilles solar park project entity, at the same financials terms as French investors on the Lumo platform.
