## Introduction

**A2ndvoice CIC** has received funding from South West London Integrated Care Board (SWL ICB) to work with children, young people and their families in Merton and Wandsworth to hear their feedback, views, and experiences about one or more of the following:

- Physical activity - what support and services are important to be healthy and maintain a healthy weight.
- Mental wellbeing – what support and services are important to maintain positive mental health and wellbeing.
- Our local environment (see definition in section 1) - what makes our environments healthy and positive for our physical and mental wellbeing in our communities and health and care services.
- The wider determinants of health and the impact on our physical and mental wellbeing, e.g. employment, housing, education, social connections.
- Transition from child and adolescent mental health services (CAMHS) to adult mental health services

We will be hosting a range of indoor activities for autistic children and young people, including siblings with their families.

Session will include bouncy castles, soft play, messy play, arts and crafts, gaming, board games, plus more with autism SEN consultants. Advisable for children to bring additional clothing and towel for the messy play session.
