

Terms and Conditions

MEMBERSHIP

Minims Music membership is payable monthly by Subscription or termly. The choir meets for 36 weeks of the year in term time (3 Academic terms split into twelve week terms) with performances throughout the year. The conductor reserves the right to add in extra rehearsals for performances, if necessary, which will of course be included in the subscription/termly fee.

When joining part way through a month, payment will be automatically adjusted and charged by the number of sessions in that month for Subscriptions. Payment is made via our booking system on the Minims Musical Theatre website and the subscription will be taken at the beginning of each month through the card company, Stripe.

A member is obliged to maintain sufficient funds to ensure withdrawal of the Subscription. Failure of the payment may result in a member being charged for re-billing.

We reserve the right to increase the price of membership. We will give you at least 1 full months' notice of any price increase and will make it clear when the price increase will take effect and how much your membership will cost after the increase.

During this notice period you may terminate your membership in accordance with these terms and conditions. If you choose not to terminate your membership before the date the increase becomes effective, the price of your membership will be increased in accordance with our notice. If you are paying by Subscription your monthly payments will automatically be amended to cover the new price.

Please make sure you are signed up for the term to pay for the rehearsals, BEFORE coming to the rehearsal.

MEMBERSHIP CANCELLATION

A months' notice is required to cancel the subscription. Please email minismusicaltheatre@gmail.com if you wish to cancel the subscription.

ABSENCE

We do not offer refunds for non-attendance.

Should a session be cancelled for any reason, an extra rehearsal will be provided within the next two terms. We will endeavour to give as much notice as possible to any change of scheduling.

PERFORMANCES

Minims Music members do not pay to perform although it may be necessary to charge for transport, props or costumes. All performances and events are optional, if a member does not wish to perform in a concert, please let the conductor know as soon as possible.

CHANGES

Minims Music may move a rehearsal venue to a new one or move a Choir Leader to another location. In these instances, Minims will ensure the change is communicated to members as soon as is practicably possible and endeavour to put alternative arrangements or plans in.

BEHAVIOURS

Minims Music aims to create a safe and positive environment for all its members, leaders and staff.

- All Members should be punctual to rehearsals and adhere to rehearsal and performance times.
- Be Kind to each other and the choir leader. Failure to do so will result in you being asked to leave the choir.
- Members are responsible for their own Health & Safety at all times. Please make the choir leader aware of any medical conditions before the rehearsal or via email.

As a member, you agree that photographs and sound and video recordings may be taken of all the members and used for advertising and marketing purposes in relation to the Choir. You consent to incidental inclusion in such materials that we may take from time to time.
