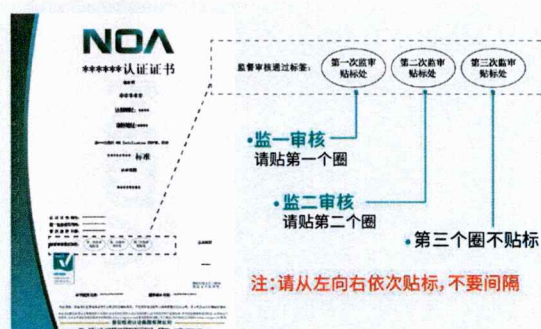


图 2 操作方法
