Explanatory notes:

1. Your Peter Justesen representative receives and check your order for item availability etc.
2. Some items may not be available in our main warehouse and will have to be retrieved from remote warehouses.
3. Trucking days varies depending on which EU port the order will be shipped from. Orders containing dangerous goods (perfume, batteries etc.) must be handed over in the port, earlier than non-dangerous goods orders, depending on shipping line's internal guidelines.
4. Indicated by information from airlines / shipping lines. Any delay that may occur due to change in vessel rotations, port congestions etc. is beyond Peter Justesen's control.
5. Process time for customs clearance depends on whether your order has already been approved by Ministry of Foreign Affairs upon arrival of the order, as well as handling time by the local customs authorities.
6. Varies depending on order size and your location from the airport- or port terminal.
